AIAVAP's Morning Textile Arts Camp takes place at our sunny studio in the Upper West Side. During each 2-week session, campers will design and create their very own multi-media **fabric art** composition inspired by medieval tapestries and contemporary fiber art works such as those by the American Artist Sheila Hicks! Campers will draw, paint, and employ textile art methods such as **sewing, quilting, applique**, rug-hooking, **block printing** and more! This morning camp will include outdoor **sketching** trips in central park. This camp is open to all skill levels!

Campers continuing for the ART/PM Camp must bring a cold lunch. Pick-up for campers not continuing for the afternoon is at 12:30pm.

AIAVAP's Afternoon Fine Art Camp takes place at our sunny studio in the Upper West Side. Each session includes **weekly trips to the Metropolitan Museum of Art** where we will visit 3 to 5 fine art paintings and sculptures. Campers will **discuss, sketch** and **be inspired** by the master artworks at the MET! Back in the studio, campers will create their own works of art while learning the skills and techniques that professional artists use in their own fine art. Skills taught include **drawing**, and **painting** in a variety of mediums, as well as **sculpting** in potter's clay. This camp is open to all skill levels!

During ART/PM we also offer Portfolio Development for tweens/teens.

## SUMMER 2015 ART CAMPS! PARENT AGREEMENT

I understand and agree:

1. That a spot is saved for my child only after tuition is paid in full for each session I registered him/her for. That there are no tuition reimbursements after dates indicated (see #5) I signed my child up for camp. That this registration and payment is for the Summer Art Camp Session(s) indicated above and that I shall not be entitled to any tuition reimbursements or deductions for my child's absences or illnesses during the session(s); that in the event of my child's withdrawal or suspension (see #5) after my child has started camp, I shall not be entitled to any refund of the balance of unused tuition, nor will I be entitled to transfer the balance of unused tuition to another child or camp session or semester payment.
2. That if I for any reason, AIAVAP decides to refund a portion of what I have paid, AIAVAP will not return the non-refundable \$40 registration fee and will deduct \$60 (cancellation fee) in addition to the fee(s) for the session(s) that my child attended. AIAVAP will not issue refunds for camp days my child did not attend due to illness(es) and/or planned or unplanned family activities.
3. To the AIAVAP REFUND POLICY: Requests for refunds must be submitted in writing to the Program Director. Refunds are made in the same form as the payment within 30 days of written request.
  - 14 days before the first day of the scheduled camp session, class tuition and materials fee will be refunded (less the \$40 non-refundable registration fee and a cancellation fee of \$60).
  - Within 2 weeks of the start of the camp, AIAVAP will provide a full refund (less the \$40 registration fee and a cancellation fee of \$60) ONLY if AIAVAP is able to fill my child's spot in the camp. If AIAVAP is unable to fill my child's spot in the camp, the entirety of my fees paid are non-refundable.
  - After the camp has begun, no requests for refunds will be accepted.
  - In the highly unlikely case that AIAVAP must cancel a camp due to under-enrollment, full refunds of camp fee and materials fee will be issued (less the fee(s) for the camp day(s) the child has attended and \$40 non-refundable registration fee).
4. Please refer to AIAVAP's camp schedules (calendar available at: [www.artsinactionvap.org](http://www.artsinactionvap.org)) if you not sure if there will be camp. AIAVAP does not exclusively follow either Public or Private School Calendars. AIAVAP does not offer make-ups for any missed camp days.
5. That AIAVAP requires my child to meet certain standards of behavior and that if my child fails to behave or demonstrates repeated unsatisfactory conduct; the Program has the right to dismiss my child from the Program without reimbursement for the balance of any unattended classes.
6. That AIAVAP is not responsible for stains & damages to my child's clothing during camp. AIAVAP encourages parents & guardians to have children "dress for mess";
7. That if my child is not picked up by the scheduled end of camp, I will pay the lateness fee of \$1 per minute. In the event that no AIAVAP staff member is available to supervise my child after 30 minutes after the scheduled end of camp, AIAVAP reserves the right to leave my child with the staff of Little Shop of Crafts (LSC) until I arrive. LSC staff will not be responsible for the supervision of my child.
8. That if my child is injured and requires medical attention and I (or the contacts I provided on the registration form) cannot be reached for instructions, I do hereby give authority to AIAVAP to obtain necessary emergency medical treatment for my child with the understanding that the family will be notified as soon as possible. I give permission for AIAVAP personnel to treat minor injuries on site;
9. That AIAVAP reserves the right to modify the camps, change instructors or site as necessary, or to cancel the class if it does not meet enrollment requirements;
10. That during the camp(s), my child may be photographed and/or videotaped by AIAVAP personnel or its authorized agents exclusively for internal and/or promotional use;

11. That my child's artwork produced during the AIAVAP camp(s), may be photocopied or copied using other methods to be used in publications and/or fundraising for AIAVAP without remuneration;
12. That camp(s) may involve trips outside the building supervised by staff of the Arts in Action Visual Art Program. I give AIAVAP permission to take my child to go on any such trips organized as part of the Program, including (but not limited to) neighborhood parks, galleries, artist studios, museums and other schools;
13. That AIAVAP is a Nuts & Sweets free environment & will not send my child to class with these food items. AIAVAP strongly suggests that your child not consume foods containing nuts and sugars before the start of class for the health and safety of our campers and staff;
14. That in consideration of allowing my child to participate in AIAVAP, I hereby release and forever discharge AIAVAP and Little Shop of Crafts and its officers, volunteers, employees, contractors and agents from any liability arising out of or based upon any bodily injury or property damage which may be sustained by my child while participating in such program;
15. That each parent/guardian must notify AIAVAP by phone (917) 741-2297 when their child will not be attending camp 24 hours in advance. AIAVAP will not be held responsible for children who are not in attendance in the AIAVAP Studio/Classroom.
16. That these terms of agreement listed above will be applicable for June 29, 2015 through August 31, 2015.
