


The Clean Ocean Zone (COZ)



NY/NJ Bight is at the intersection of warm waters from the Gulf Stream and cold waters from the Labrador Current


The NY/NJ Bight is surrounded by some of the most densely populated urban areas in the nation

- 25 species of mammals and sea turtles










COZ: Unique Value






COZ: Threats

- Ocean Industrialization
- Liquefied Natural Gas Terminals
- Oil and Gas Surveys, Explorations, and Drilling
 - E.g., BOEM 2012 "Atlantic Ocean G&G Activities EIS"
- New Point Sources of Pollution
- Ocean Dumpsites and Sediment Contamination





COZ: Solution

Lock in Progress, Lock Out New Sources of Pollution

Move beyond the need to fight battle after battle, year after year, to prevent ocean pollution and industrialization



COZ: Reducing Pollution

- **Prohibit** new ocean dumpsites.
- Mandate capping of the Historic Area Remediation Site (HARS) –
 formerly the Mud Dump Site with progressively cleaner sediment to
 ensure the remediation of the HARS and to protect against adverse
 ecological effects.
- **Prohibit** new point sources of pollution and increases of discharge capacity (e.g., wastewater discharge outfalls, industrial discharges) to encourage environmentally protective beneficial reuse of wastewater.

COZ: Protecting Ecosystems

- **Prohibit** the permanent extraction (e.g. strip-mining) of natural non-renewable resources, including sand and gravel, while allowing beach replenishment.
- **Prohibit** industrial and non-renewable energy facilities and infrastructure, <u>including oil and gas exploration and development</u>.
- **Require** the development of responsible regulations for renewable energy sources. The Energy Policy Act of 2005 delegates this to the Bureau of Ocean Energy Management, but under the COZ, NOAA will have "concurrence" authority over energy facility siting.

COZ: Supporting Resources

- Support recreational and commercial fishing.
 - The COZ acknowledges that there are already federal and state laws for managing fisheries *already*; that the COZ is for pollution prevention and cannot be used for fishery management actions.
- **Support** federal and state approved artificial reefs, and allow underwater research and exploration.
 - Except projects that will adversely affect the ecosystem.
- **Support**, **celebrate**, **and sustain** maritime activities that depend on a healthy and clean ocean, such as: boating, underwater diving, fishing, surfing, swimming, and the enjoyment of the sea. The COZ legislation will not be used to restrict or limit these activities.
