## IMPORTANT NOTICE FOR DRESSAGE EXHIBITORS, OFFICIALS, & MANAGERS

The USEF instituted new rules affecting competition, effective December 1, 2008. Following is a small sampling of rule revisions and additions that particularly affect dressage riders.

- GR1302.2c & GR.1309.2b: If an exhibitor does not submit the proper membership documentation...the exhibitor will be responsible to pay a \$30 non-refundable fee
- DR120.1: Smooth half chaps are legal through First level
- DR 120.5: New whip length: 120 cm or 47.2 inches
- DR 120.11: Cooling vest may be worn under a riding jacket
- DR 126.3: Competitions may reserve the right to fill ride times in the event of a "no show"
- DR 128.9: In order to enter a musical freestyle the rider MUST have a score of 60% or better in the highest test of that level.

## INCREASE IN PRIZE MONEY AT GREAT AMERICAN/USDF REGIONAL DRESSAGE CHAMPIONSHIPS

The USDF and Great American Insurance Group have announced that prize money at the Great American/USDF Regional Dressage Championships has been increased to include the adult amateur and junior/young rider divisions at both the Intermediate II and Grand Prix levels

In total, over \$143,000 in prize money will be awarded at the 2009 Regional Championships, divided evenly among the nine regions and 35 divisions that are offered. Champions in each division will receive \$273 in prize money and an embroidered jacket and cooler provided by TuffRider. Reserve champions will receive \$182 in prize money along with a saddle pad provided by Great American Insurance Group.

The Region 4 Championship will be held September 4-6 in Mason City, IA. Region 2 Championships will be held at Lamplight Equestrian Center in Wayne, IL, October 2-4.

Lilo Fore, of Santa Rosa, CA, is an FEI "I" judge and is an Examiner for the USDF Instructor Certification program. She is also an Examiner for the USDF Sporthorse Breeding program, and has trained horses and riders on the national and international levels. She frequently offers dressage clinics around the world and at her own facility in Sonoma County.

**Clinic Fee:** \$520 for three 45-minute sessions, one per day.

Clinic Fee includes one stall with first bedding, shared use of a tack stall, Horse Fair exhibitor badge for rider, plus one weekend pass to Horse Fair.

Although horses of every level are encouraged, more upper level than lower level horses will be selected for the eight available slots. Be prepared to provide a video of you riding your horse in the final selection phase. Horses will be chosen by quality and breed variety.

Horse Fair pass holders are encouraged to audit the clinic. General admission to Horse Fair is \$13 per day or \$20 for the entire weekend.

**Clinic Schedule:** Daily lessons run from 7 a.m. to 1:30 p.m. in Barn 13. On Saturday at 2 p.m., Dr. Gerd Heuschmann's documentary, "If Horses Could Speak", will be presented with commentary by Ms. Fore in the Seminar Hall on the lower level of the Livestock Center.

## USDF "L" EDUCATION PROGRAM WELCOMES AUDITORS

The Wisconsin Dressage and Combined Training Association (WDCTA) has announced the schedule for the 2009 USDF Region 2 "L" Education Program.

The USDF "L" Program was created to teach participants and auditors how to evaluate dressage performance at Training through Second Levels. After graduating from the "L" Program, candidates may apply to USEF for the 'r' Judges Training Program to become a licensed judge.

However, the "L" Program is not just for those who want to become licensed judges. The program's intent is to give competitors, trainers, and instructors a broader insight into the evaluative techniques of judging dressage, qualify individuals to officiate at schooling shows, serve as continuing education for licensed judges, and to serve as a prerequisites for entering into the United States Equestrian Federation 'r' Judges Training Program.

- March 14-15: Session A, "Introduction to Judging and Biomechanics." Instructor: Jayne Ayers
- April 26-27: Session B, "Gaits & Paces, Movements & Figures." Instructor: Debbie Riehl-Rodriguez
- May 23-24: Session C, "Basics, Collective Marks, Rider Biomechanics, & Equitation," Instructor: Sandy Howard

Sessions A, B, and C may be audited for a cost of \$65.00 for each session, payable in advance or \$75 as a walk-in. This includes any materials (other than the Dressage Glossary) that may be needed for these sessions. The Dressage Glossary will be available for purchase at the sessions.

President Tracey Walker called the meeting to order at 1:30pm. The minutes of the last meeting were read and approved as amended. There was no treasurers report at this meeting.

### Old Business

#### Membership fees

After the board discussed a discounted membership rate for early sign-up, Marilyn Weber moved that memberships be reduced to \$25 for adults and \$15 until November 15. Pinky Noll seconded the motion, which carried unanimously.

#### By-Law changes

We already have a contract with Lilo Fore for Horse Fair weekend, we just need to decide how to use her, at Horse Fair and/or in clinic lessons at StarWest.

### Annual Christmas Party

This year's party will be hosted by Pratense Farms. Members who plan to attend are asked to bring a dish to share. Paula will do the invitation and Tracey will track RSVPs.

### Academic scholarship

There is one application for the scholarship this year, and when the references arrive, Janet will send copies of the complete application to fellow committee members, Marilyn Weber and Alice Martin.

The meeting adjourned at 3:00 pm.
