## **Additional Details**

### **Security & Damage Deposit**

Required for any event

### **Reservation Hold**

A courtesy hold for your desired event date will be placed for fourteen (14) days. If a contract has not been initiated within this time frame, the reservation will drop from the calendar.

### **Contract**

Once the contract has been issued, client has fourteen (14) days to return signed contract along with the required deposit to insure desired date.

### **Payments**

The deposit(s) and payment(s) requirement for your specific event will be found in the contract. A 30% deposit of the current estimate will be due at time of signing. We must maintain a copy of a valid credit card on file for any event expenses that will be incurred over and above expenses detailed and agreed to in the Event Contract.

### **Return of Security Deposit & Payment of Commissions**

Refundable security deposits will be sent out at the end of each month.

### **Date Changes**

A date change agreed to by both parties after the contract is issued does not incur penalties and deposit monies are transferred to the new date.

### **Vendors**

The Mill House has a list of very reputable, experienced vendors from which to choose. We choose these vendors because of our working relationships with them and know the quality of work and level of professionalism that each vendor provides.

## **Mill House Rules**

### **Music**

Outdoor music must stop at 8:30 pm and indoor music must conclude by 9:45 pm. Live outdoor music may include up to a three piece band. The Mill House must approve all music. All dancing and party music must occur inside The Mill House. iPod Players are allowed but must be supervised by an approved Sound Technician. Noise curfew is 10:00 pm, music and excessive noise must cease at that time or refund is at risk. Decibel Readers must be used by all DJ's.

### **Conclusion of event**

Event must conclude by 10:00 pm and all guests must be off property by 10:30 pm.

### **Alcohol**

All guests consuming alcohol must be at least 21 years of age and should have valid identification on them. Bartenders will refuse the sale of alcohol to any person who does not appear to be of legal age and cannot produce proper identification. Any person drinking illegally will be asked to leave the property. Management staff may refuse service to anyone who becomes overly intoxicated.

### **Parking**

All guests and staff must park in designated parking areas only. Driving on any lawn is prohibited.

### **Shuttle Service**

If you choose to provide your guests with shuttle service, shuttles or motor coaches are prohibited from sitting in the parking area with their engines running.

### **Smoking**

There is a “no smoking” rule for The Mill House and adjacent areas. Smoking will only be permitted in designated outdoor areas. A cigarette butt receptacle will be provided in the designated smoking area.

### **Exterior Spaces**

Any damage to lawn, plantings, or irrigation will result in a deduction from security deposit.

### **Set up and Breakdown**

Setup can begin no earlier than 8:00 am, the day of your event. ***Specific setup time(s) will be noted and agreed to in your Event Contract.*** All rentals must be removed by 10:30 pm nightly or must be picked up no earlier than 8:00 am the morning following the event. No outside activities will be permitted from 10:30 pm to 8:00 am. To insure security deposit is refunded, property should be inspected the following morning.
