Cost \$65 per year (January to December – new members after Sept. 1 are good through the following year). Complete application at the Fremont Market Info desk any Sunday morning before 11 a.m. for immediate processing. Please make checks out to FSM.

Benefits: You can prepay for space as far into future as desired, write checks to the Market, receive referrals to your business when you are not at Market and someone is looking for you, vend more than one time per year. (City requires membership after one visit)

Reminder, you MUST have a Washington State UBI number and a Seattle City Business license to become a member of FSM (produce ONLY is exempt).

MARKET RULES AND WAIVER

Read each line, check each box and sign

- LOAD IN:** Pull up on right, immediately unload, go to designated vendor parking, THEN set up.
- NO CARS** allowed on street after 9:45 am or before closing. Obey traffic monitors at all times.
- CUSTOMER ACCESS:** Pick up at West or East end by flags. Ask street monitor for Loading Dollies.
- AVOID GYM** Parking lot for loading in or out, or for parking. They ticket and tow!
- NO EARLY BREAKDOWN:** You are required to stay the entire day. In case of emergency, obtain Market Staff assistance.
- BE PACKED UP AND BROKEN DOWN BEFORE** bringing car onto the street to avoid choking the street.
- NO VENDOR PETS ON-SITE:** Insurance liability, no exceptions
- NO TRACE:** Clean your space. Leave no trace. Broken glass – NEVER put in garbage. Ask staff to dispose.
- NO OOZING:** Keep your display within one foot of all booth lines, no more.
- SIDEWALKS:** Wheel-chair access must be easy along entire sidewalk area. Do NOT block!
- NO PARKING: on PUBLIC STREETS or GYM** parking. Willful disregard - \$50 FINE (The Market provides free parking – check with desk manager for passes.)
- RESTROOMS:** FSM has 1 port-a-can at the West end and 2 indoor restrooms in the garage. The Red Door will allow some restroom traffic if respectful and neat.
- LICENSES:** To be a member of FSM you must have a Washington State UBI & Seattle City Business License. First two times to vend not needed, after that membership and licenses a must.
- CANOPIES:** All canopies must have minimum 20 pound weights attached to each leg, or no canopy roof.

- PRODUCT POLICIES:** NO Prepared foods without permit, no brand retail, financial services, health or treatment services, realty, franchises or their DBA's. Dollar store merchandise, knockoffs and such types of imports will be discouraged. **ALL FOOD PRODUCTS are restricted due to Health Department regulations and require written application and interview.**
 - NO firearms of any description**, products with blades require manager approval. No sales of pets allowed. No pornography, or offensively smelly items. Presence of stolen goods = immediate expulsion.
 - RIGHTS & REQUIREMENTS:** We reserve the right to disallow the sale of any items we deem unsafe, illegal or undesirable. We reserve the right to refuse service or to terminate membership and participation for any reason.
 - WAIVER & RELEASE:** I waive my right to sue, and agree to defend, indemnify and hold the Fremont Sunday Market, its owners, employees and agents harmless from lawsuits brought by myself, or my heirs, from and against any and all liability, loss and expense (including reasonable attorney's fees) or claims for injury or damages now or in the future that may arise out of my use of the Fremont Sunday Market's facilities, including but not limited to the parking garage, street space, Burke Building lots and U-Park lots, or out of my participation in Fremont Market programs or event services.
