## GUIDELINES AND ELIGIBILITY

- Entry Forms/fees must be received a week in advance of the Art Market Day. You will be notified via email of acceptance and space number. Each Market date requires a new entry form. We will begin accepting forms for the NEXT Art Market on the day of the current Art Market or after.
- There are a limited number of spaces. If all the spaces have been filled, you will be contacted and will be put at the top of the list for the next Art Market. ART MARKET FEES ARE NON-REFUNDABLE for those who are assigned a space, then cancel or do not appear.
- Artists must submit a photo example of their work with their Entry form (once established an artist need not submit examples for future Art Markets). Photos submitted will not be returned.
- All Artists must be current members of the Calistoga Art Center at the time of entering and participating in Art Market. You may sign up for or renew your membership at the time you submit your entry form
- All art must be original works (prints OK) and produced by the artist.
- Artists may apply for one or two spaces (about 8' x 8' each) at \$25 per space. Spaces will be assigned by CAC prior to Market day
- Artists may begin set up at 9am and must have space ready for 11am opening. CAC cannot provide assistance in loading, unloading or setting up your space.
- Artists may bring in their own table and displays, but they must fit within their designated space
- Artists (or their representative) are required to be at the venue the entire hours of the Art Market and may not pack up or leave early. The CAC must vacated by 6pm.
- All transactions must be handled by the artist, including collection of payment, shipping, sales taxes and tax reporting, etc
- **THE ARTISTS RETAIN ALL OF THE PROCEEDS FROM THEIR ART SALES. CAC retains entry fees.**

I acknowledge that by participating in this event the Calistoga Art Center and its representatives will not be held responsible for any personal injury or for any loss/damage of my artwork or personal property through any cause.
