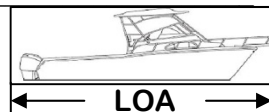

Spring launching and cleaning are included in winter storage.

- _____ **Shrinkwrap Removal & / Canvas Cover Removal Flat Rate \$3/ft.LOA**
Remove shrinkwrap or canvas cover. Package up for recycling, pickup or storage.
- _____ **Freshwater System Recommission (est.\$50-\$150) Time& materials**
Includes flushing & filling tank, treating with deodorizer /cleaner, check system operation, recommission Vacu-flush head.
- _____ **Bilge and Navigation light check(est. \$50-\$150) Time & materials**
Test bilge pump(s) & Navigation lights, repair as necessary.
- _____ **12 volt system check(estimate \$50-\$150) Time & materials**
Test all battery operated boat systems & repair as necessary, advise if repairs exceed estimate.
- _____ **Bottom painting Flat Rate \$16/ft. Boat Length**
Tape paint line, apply one coat of Interlux BottomKote ACT, remove tape and dispose of materials.
- _____ **Hydraulic Steering System Service (est. \$50-\$150) Time & materials**
Disassembly, inspection, lubrication and reassembly of outboard motor mounted steering cylinder(s).
- _____ **Anode replacement (est.\$50-\$250 per boat) Time & materials**
Replace external anodes on motor(s), boat trim tabs and bow thruster as applicable.

Replacement of the spark plugs and primary engine fuel filter, connect battery, test run on hose check for fluid leaks, verify proper throttle & shifting operation, water test motor if the boat is to be picked up by water.

1. I hereby authorize the repair work described along with the necessary materials. You and your employees may operate the unit herein on any waterway or elsewhere for the purpose of testing, inspecting or delivery at my risk. I agree to be personally responsible for all attorney fees incurred by Somers Point Marina to collect any outstanding balances.
2. I agree that Somers Point Marina shall not be liable for any losses, damages or injuries due to theft, fire, vandalism, Acts of God or any other conditions beyond our control to said PWC, Jet Boat, boat, motor(s), trailer and contents or any other property on Somers Point Marina's premises.
3. Somers Point Marina reserves the right to move the unit(s) any time within Somers Point Marina's premises and storage lots.
4. Owners must fully insure their PWC/Jet Boat/boat/motor(s)/trailers with complete Marina Insurance, including hull coverage and indemnity and/or liability insurance and furnish Somers Point Marina with the insurance carrier's name and policy number.
5. The owner acknowledges that Somers Point Marina has all the appropriate Maritime liens, either Federal or State, upon the boat, motor(s), and accessories thereof, to secure any and all space rental fees, repair, gas, oil, maritime hardware, accessories, or other services or materials rendered to or supplied to owner for use upon the stored boat. I agree that all charges under the terms of this agreement shall be paid promptly, net 10 days. Interest at the rate of 2% per month or fraction thereof will be charged on all past due accounts. Boats left on Somers Point Marina premises for a period of 6 months without the payment of storage or repair bills will be considered abandoned, and seizure and sale procedures will be instituted under the laws of the State of New Jersey.
6. Jurisdiction: In the event that there are disputes concerning any services performed by Somers Point Marina, I agree the jurisdiction shall be vested in the Superior Court of New Jersey, Law division at the Atlantic County Civil Courts, Atlantic City, New Jersey and hereby consent to in personam jurisdiction, by means of forwarding a summons and complaint by certified mail, return receipt requested.
7. Due to insurance regulations no independent contractors, service organizations or outside individuals will be allowed to perform work or enter the Somers Point Marina facility without first obtaining permission. All contractors, organizations or individuals are required to provide Somers Point Marina with a certificate of insurance coverage. Said certificate shall include coverage for liability, worker compensation and name Somers Point Marina as additional insured.
8. Trailers left at Somers Point Marina will be charged for storage at a rate of \$4.00/day or \$250 for the summer season. The summer season runs thru September 31, 2015.
9. Boats in winter storage not scheduled for launch by May 31, 2015 will be placed into summer storage. Summer Summer boat storage is \$24/ft. LOA. The summer season runs thru September 31. 2015.
10. Boats not retrieved within 10 days of their launch date will be subject to hauling and storage charges. Boat delivery is available.
