Electricity Rebates: are you getting yours?



INTRODUCTION

Some state and Commonwealth Government departments and agencies provide rebates and concessions to help some people with their electricity costs. Further rebates may be provided by utility companies and welfare agencies. People holding pensioner concession cards or with certain medical conditions may be entitled to a rebate. Many residents in remote communities and town camps have pre-payment meters (PPM). They buy 'power cards' and insert these into the at their home to get power to their house. When you access electricity using power cards you don't have an account number with a Utility. Most Utilities and government agencies require an account number to process electricity rebates.

If you don't operate your electricity by using a power card, you will have an account number. If you meet the eligibility requirements you may be able to get a rebate.

This BUSH TECH explains the different electricity rebates available and how to apply for them.
