Type of Scholarship Requested:

- Youth Membership (ages 0-15): An annual youth membership is \$95.00. A scholarship will generally cover 75% of the fee. A \$25.00 payment would be needed. *(A Youth Membership is required to receive a Youth Program Scholarship)*
- Young Adult (ages 16-17) Membership (\$130 value/year): This Young Adult Membership will expire at age 18. A \$40.00 payment is required at time of initiating the membership.
- Young Adult (age 18) Membership (\$130 value): A Young Adult Membership will expire at age 19. A \$40.00 payment is required at time of initiating the membership.

The Y will generally approve a scholarship of up to half of the value of the member program fee. If additional financial assistance is required, please contact the Y at 662-2109 and request an appointment for a scholarship interview.
