





CHARLIE SHEEN IS AHEAD OF HIS TIME!



Born on September 3, 1965, Charlie Sheen, like many great people, was destined to become a man ahead of his time. In fact, Charlie could well be the poster boy for the fact that prostitutes are cheaper than gold diggers. If nothing else, his failed (and expensive) marriages taught him that. So, as time marches on, Charlie increasingly marches away from matrimony and its gold diggers and toward the live-for-today, far less costly fun of prostitutes, porn stars and live-in "goddesses." Charlie has truly become a role model for budget conscious, sexually promiscuous, fun loving men everywhere. Long live King of Pussy Charlie Sheen!

His amazing talents as a player no doubt contributed both to Charlie Sheen's success on *Two and a Half Men* and his success with a multitude of women, particularly prostitutes and porn stars. He has all the perfect attributes for this success, including:

- Hollywood celebrity status.
- Non-judgmental attitude about porn stars, drug dealers and prostitutes.
- Mastery of the art of seduction.
- Knowledge of how to perform comedy, to entertain his fans and introduce pop cultural phrases.
- Believing in and practicing sexual promiscuity and open sexual relationships.
- Only pursues and seduces beautiful women.
- Possess a net worth of millions which is always useful in convincing women to have sex especially

if some of the money is shared with them.

One would expect nothing less from a "rock star from Mars with tiger blood and Adonis DNA."

If nothing else, Charlie Sheen has proven himself to be an expert multi-tasker. While he was establishing his reputation as the world's greatest pussy hound and drug dealers' favorite customer, Charlie was accumulating impressive credits as an actor. In the movie world, Charlie has starred in several movies including Ferris Bueller's Day Off (1986), Platoon (1986), Wall Street (1987), Major League (1989), Hot Shots! (1991), Scary Movie 3 (2003), Scary Movie 4 (2006), Machette Kills (2013), and Scary Movie 5 (2013). Charlie is most famous on television for his performances in Spin City, Two and a Half Men, and Anger Management. Charlie was making \$1.8 million per episode of Two and a Half Men in 2010 making him the highest paid actor on television. That kind of cash can buy a lot of women and drugs, and Charlie was determined not to waste those opportunities. Charlie was awarded a star on the Hollywood Walk of Fame for his acting achievements in 1994. Now if there were only an award for Charlie's sexual conquests as a player. After a very public and extensive, drug-fueled meltdown, Charlie was dismissed from Two and a Half Men on March 7, 2011. He was replaced by Ashton Kutcher. Charlie went on to star in his next series Anger Management for FX. Charlie's larger than life lifestyle and legendary sexual adventures has spawned a plethora of Charlie Sheen themed porn movies starring one or more of his porn star girlfriends to the point where they have become their own porn movie genre.

Over the years Charlie has participated in three marriages and divorces, produce five children not all in marriage, and had sex with seemingly dozens of former and present girlfriends both porn stars and Hollywood actresses. No one has ever called him Mr. Commitment.

September 3, 1995 marked Charlie's first marriage, to model Donna Peele, which lasted barely a

year ending in divorce on November 19, 1996 after an escort agency operated by notorious Hollywood Madam Heidi Fleiss got in trouble with the law and Charlie was outed as one of the agency's clients to the tune of \$50,000 he had spent on prostitutes. That is, as *Led Zeppelin* put it, a whole lotta love. At the time of their marriage Charlie described Peele by saying, "She's an angel sent from Heaven to take me through the rest of my journey." However, at the time of their divorce Charlie compared Peele to a vehicle, "You buy a bad car, it breaks down."

Actress, model, and former Bond girl Denise Richards (born February 17, 1971) became wife #2 on June 15, 2002. Let us get right to the dirt. Richards filed for divorce while she was pregnant with their second daughter. And just to make her feelings for Charlie crystal clear, she filed a restraining order against Charlie, accusing him of making death threats to her. Clearly, Charlie was accumulating experience for his future *Anger Management* show. The divorce was finalized on November 30, 2006 and Richards' payoff for having dealt with Charlie was reportedly: \$52,000 per month tax-free in child support, \$60,000 per month tax-free in alimony for two years, in addition to a percentage of Charlie's sit-com, *Two and a Half Man*, which comes out to \$25 million. Talk about hitting the jackpot without even setting foot in Las Vegas!

For his third marriage, on May 30, 2008, Charlie took a break from celebrities and porn stars to marry socialite Brooke Mueller (born August 19, 1977). They produced two sons. In 2009, Sheen received a restraining order from Mueller. She accused him of assault and of being insane. But keep in mind that Mueller herself has been in rehab for alcohol and drug issues. Their divorce was finalized on May 2, 2011. Mueller reportedly received a lump sum of \$757,698.70 plus \$1 million for her share of their mari-


tal home, and \$55,000 per month in child support. 'Til death, alimony or child support do us part.

Will Charlie marry again? Not if his own words are to be believed: "I tried marriage. I'm 0 for 3 with the marriage thing. So, being a ballplayer I believe in numbers. I'm not going 0 for 4. I'm not wearing a golden sombrero."

Of the more than 40 women whom Charlie Sheen has been publicly linked (and there are probably hundreds of other women who remain anonymous) many have been porn stars. Why porn stars? As Charlie has stated, "It's exciting, it's fun, because you already know what you're getting before you meet them. They're the best at what they do, I'm the best at what I do. It's on." As to a judge's question about why a man like Charlie would need to pay for sex with prostitutes, Charlie responded, "I don't pay them for sex. I pay them to leave." Charlie also said, "It eliminates a lot of hassle. There's no emotional attachment." As you might have guessed, no one has ever accused Charlie of being overly romantic.

Here is a representative sampling of some of Charlie Sheen's porn star girlfriends:

GINGER LYNN. Meeting him on the set of *Young Guns II*, porn model and hardcore actress Ginger Lynn was Charlie Sheen's girlfriend from 1990-1992, including providing assistance to him in drug rehabilitation. And can there be any closer bond between a man and a woman than that? But Charlie

supported her, too, writing letters to the court on her behalf during her federal tax evasion trial and subsequent 4 ½ month prison sentence. What did he see in her? In AVN's list of the greatest porn stars of all time, Lynn was ranked as #7. Despite their breakup, Lynn kept a place for Charlie in her heart. "It wasn't that Charlie wasn't a good lover, he just needed to learn to pay attention to someone other than himself ... I was a fabulous teacher and Charlie was a wonderful pupil," as Lynn later explained to *E! True Hollywood Story*. School would no doubt have been more interesting if we had teachers like Ginger Lynn.

HEIDI FLEISS. An infamous prostitution scandal brought the Hollywood Madam Heidi Fleiss to America's attention, but Charlie Sheen and Fleiss were known to be dating before that. At 22, while apprenticing with the famed Madam Alex, Fleiss worked as a prostitute as part of her goal to learn all aspects of the business. Now that's commitment. She opened her own prostitution ring in 1990, earning her first million dollars in just four months and earned \$10,000 on her slowest night. It's too bad that Fleiss' achieving the American Dream was also a felony. She ended up serving 20 months in prison after her 1995 trial for tax evasion, money laundering, and conspiracy. During her trial, Charlie was her only famous client who did not desert her. He verified 7 checks he gave to her prostitutes and twenty other instances he hired them directly, for a grand total of \$53,500 in just over a year. That's enough sex for at least two and a half men! Charlie was truly a patron of the arts, if by "arts" you mean prostitutes.

KACEY JORDAN. Early in 2011, Charlie Sheen embarked upon his notorious 36 hour sex and drugs bender. During this time, 22 year old Kacey Jordan, whose real name is Courtney Roskop, was one of



the numerous porn stars with whom he partied. She said she was stunned by Charlie's behavior during this period. And if a porn star is stunned by your behavior, you know it must be pretty outrageous. At a party at Charlie's Los Angeles Mansion, for which she was paid \$5,000 to attend, Jordan stated she observed Charlie smoking from a tennis ball size pile of cocaine every two to five minutes. Jordan said, "I've never seen someone so self-destructive. I thought maybe it was almost like a suicide binge." Yet apparently his wallet was working fine. So, Jordan had sex with him and when she left the mansion, Charlie gave her a \$30,000 check. She more than doubled that money by simply talking about her experience with Charlie. Jordan revealed all on *TMZ*, *Good Morning America*, *Inside Edition*, *The Howard Stern Show* and *E! Online* among other media outlets. Her take for the gab-fest: \$70,000. Didn't Charlie ever hear of a non-disclosure agreement?

BREE OLSON. If nothing else, Charlie Sheen is consistent in his choice of women. Bree Olson, whose real name is Rachel Marie Oberlin, was a porn actress and *Penthouse Pet of the Month* (March, 2008) who also appeared on the covers of *Playboy* and *Hustler*, made over 250 adult films and was listed as one of the 12 top female stars in porn by *Maxim* magazine. In 2011 Olson lived with Charlie at his Los Angeles mansion, also known as the Sober Valley Lodge, for six months during his spiraling down period after having been fired from *Two and a Half Men*. Former nanny and model Natalie "Natty" Kenly formed the third part of the live-in trio. Trained as a kindergarten teacher, Kenly ended up working at a marijuana dispensary and as the head model for the marijuana magazine *Cali Chronic X*.

Charlie referred to both Kenly and Olson, as he does with all his live-in girlfriends, as his "goddesses." Might that just be Charlie's way of proclaiming them to be divine? Au contraire; it's far more than that, as Charlie himself elaborates: "Let me say this about the goddesses, I don't think the term is good enough, but when you're bound by these terrestrial descriptions, you must use the best term available. So what we all have is a marriage of the hearts. And to sully, contaminate, or radically disrespect this unit with a shameful contract is something I'll leave to the amateurs and bible grippers." Or perhaps "goddesses" has something to do with all the exclamations of "Oh, God! Oh, God!" when they are together. Apparently, that was one of Charlie's strengths, according to Olson: "He's just a rock star. He's a powerhouse. He's a very sensual and sexual person, and when I was with him I felt as if we became one together, because he's just so enticing sexually." But not enticing enough, apparently, to stay with him. Olson is now single, living on her own in L.A., and pursuing a career as a mainstream actress, no doubt finding that casting directors will most likely not be treating her as a goddess.

CAPRI ANDERSON. Ah, what's life without a porn actress giving interviews to *ABC News, Nightline* and *Good Morning America* that you were drunk, trashed a hotel room, called her a whore, and in a coke-fueled rampage, threatened to kill her? That's the situation Charlie Sheen found himself in during November of 2010. It started on October 26, 2010, though, when police were called to New York City's Plaza Hotel to find porn actress Capri Anderson, whose real name is Christina Walsh, locked in the bathroom of Charlie's hotel room in an attempt to escape Charlie. Charlie had caused \$7,000 worth of damage to

their room and ended up suing Anderson for extortion, saying she requested \$1 million to keep her name out of the media. The police gave Charlie the option of going to jail or to a hospital for a psychiatric evaluation. He chose the hospital. Fast forward to August of 2013 when, unbelievably, Charlie was living with both Anderson and another porn star, Georgia Jones, at his Los Angeles mansion. Hey, if you can not forgive a porn star and pay for her to live with you, what's life about, anyway?

THE HOWARD STERN SHOW'S CHARLIE SHEEN PORN STAR GIRLFRIEND BEAUTY PAG-

EANT. If you tuned in to Sirius XM Radio on March 3, 2011, you could have heard *The Howard Stern Show's Charlie Sheen Porn Star Girlfriend Pageant*. Apparently, *PBS's Masterpiece Theater* must have said "no thank you" to the entertainment extravaganza, which featured three of Charlie's former girlfriends, porn stars Capri Anderson, Melanie Rios and Kacey Jordan. Stern informed his audience that Charlie's former porn star girlfriends were competing for a \$10,000 prize put up by Beezid.com and that the judging would be based on personality and beauty which is probably a good choice for these women, as opposed to knowledge of literature, science and current events.

Stern then proceeded to interview each one with "hard-hitting" questions such as asking Jordan if she'd ever been arrested for being a prostitute. Jordan's responded that she hadn't; they get paid to "party," so it's not really prostitution. Well, that explains that! She went on to explain that she'd fantasized about having sex with her dentist, finally made it a reality, and as a result, would be receiving free

Howard next interviewed Capri Anderson, who informed him that she prefers being called a porn star rather than an escort. Finally, a contestant with standards! And when Howard asked what she would be doing next, she said even though she had not done it in the past she would be having sex with strangers. Well, it's good to have new goals. Howard asked if she ever imagine Charlie falling in love and sweeping her off her feet, but Anderson said she considers it all just business. And speaking of business, Anderson revealed she had just signed a contract with Vivid Pictures to make porn movies. Good to know that Charlie Sheen was just a stepping stone to greater achievements.

Melanie Rios, up next, was asked by Howard about the size of Charlie's penis. She stated she never saw an 8 ½ inch penis that Charlie boasted. She revealed it to be 7 or 7 ½ inches. TIGER WOODS AND ELIN NORDEGREN

DIVORCE SETTLEMENT: ESTIMATED \$100 MILLION

TIGER WOODS (BORN DECEMBER 30, 1975) is considered one of the most successful golfers ever, as well as one of the highest paid athletes in the world. According to his parents, Tiger was playing with his putter even before he could walk. Now that he can walk, he enjoys having his girlfriends play with his putter.

In 2000 he became the fifth player ever, as well as the youngest in golf history to win a grand slam of the four major golf championships the Masters, U.S. Open, British Open, and PGA Championship. He quickly found, also, that women flock to attractive men who are super athletes and very wealthy. Go figure. Tiger has used this appeal to his advantage, to say the least.

During the 2001 Open Championship in England Swedish golfer Jesper Parnevik introduced Tiger to the stunning Swedish model Elin Nordegren (born January 1, 1980). Elin was Parnevik's nanny. Tiger proposed to Nordegren in November, 2003 during the Presidents Cup tournament in South Africa at the Shamwari Game Reserve and they became officially engaged. were married on October 5, 2004 in Barbados at the Sandy Lane Resort.

This they demonstrated in 2006 by buying a \$39 million estate on Jupiter Island, Florida and building their own 10,000 square foot home there. One might think that shelling out that kind of cash for a home that size might be indicative of a committed relationship. One might be wrong, as time would soon tell.

No doubt Tiger Woods wishes he could erase the entire week of November 23, 2009. That's when the world found out through *The National Enquirer* about Tiger's affair with New York night club hostess Rachel Uchitel. The racy text messages quoted by *The National Enquirer* included, from Uchitel: "We're in love . . . I don't care about his wife!" For some reason, Nordegren took offense to all this.

Sensing some sort of apology/gift might be in order, Tiger confided to a friend that he needed to "run to Zales to get a 'Kobe Special;" a huge diamond ring to try to make things right with Nordegren. It did not. On November 27, 2009, the morning after Thanksgiving, a neighbor called 911 and informed them that Tiger had crashed into a tree in front of his house and was on the ground alongside his Cadillac Escalade. Paramedics found him in serious condition with facial lacerations. According to differing reports, Nordegren had either used a golf club to break out the car's rear windows and rescue him or used the club to destroy the windows as Tiger was driving away trying to escape her. In any case, Tiger was transported to the hospital, where he was released later that day. Not your traditional Thanksgiving celebration.

Later, the truth began to emerge that Tiger and Nordegren were having an argument just before the crash most likely either about his affair with Rachel Uchitel or about which varieties of avocados are tastiest. Nordegren had scratched up his face and he tried escaping in his car. Nordegren ran after him and most likely whacked out his car windows as he drove off. Perhaps Tiger took this as a sign that mistresses might be more sympathetic to him in the future.

The following are some examples of alleged Tiger Woods' mistresses:

RACHEL UCHITEL. Former New York City night club hostess Rachel Uchitel distinguishes herself from all the rest of the alleged Tiger Woods' mistresses as being the one who led to Tiger's fight with his wife Nordegren, which in turn led to his car crash. No doubt Tiger told Nordegren, "It's all Rachel's fault!" When the story broke that Uchitel had secret trysts with Tiger in New York, Las Vegas and Australia, she hired celebrity lawyer Gloria Allred, the bane of men who mistreat women, to represent her. The resulting publicity caused numerous women to surface, like ants emerging from an anthill, claiming that they had also slept with Tiger. It is alleged that Tiger bought Uchitel's silence, paying her \$10 million, but she had to return the money after discussing her affair on the TV show, *Celebrity Rehab with Dr. Drew.* Ouch! It was a costly television appearance.

JAIMEE GRUBBS. She has been a cocktail waitress and a contestant on the reality television show *Tool Academy*, but Jaimee Grubbs' biggest claim to fame remains being one of the first of Tiger Woods' mistresses to be outed publicly. How's that for a significant resume credit! She backed up claims of her 31 month long affair with Tiger by handing over incriminating, raunchy voicemail between the two of them. Sample, from Tiger's end: "I will wear you out...when was the last time you got fucked?" ... "Send me something very naughty. Go to the bathroom and take (a picture)." And she proved she is no rocket scientist by claiming she had no idea Tiger was married while they carried on. Perhaps she cleaned his club in a very special way. Tiger and Jungers met at the Bellagio Hotel in Vegas in 2005. Later, he invited her back to his \$5,000 a night suite at the MGM Grand Mansion hotel. Apparently, they decided not to play chess and instead had passionate sex. The first place winner of the *Tiger Woods Mistress Beauty Pageant* was Jamie Jungers. Followed by Jaimee


Grubbs in second place and third place Loredana Jolie bringing up the rear, so to speak.

WHAT A DIFFERENCE A YEAR MAKES! In 2007, recently elected Governor of New York Eliot Spitzer (born June 10, 1957) was known primarily as the two-term New York State Attorney General, from 1999 to 2006, during which time he acquired the nickname the Sheriff of Wall Street due to his dogged pursuit of people involved in white collar crime on Wall Street. In 2008, Eliot Spitzer became known primarily as "Client 9," the patron of a high priced prostitution service, or "escort agency," called Emperors Club VIP. Apparently, this was not part of his official duties as New York State Governor.

Did some vengeful call girl blow the whistle on Spitzer? Au contraire! It was his own bank account at HSBC Bank that did him in by tipping off federal investigators to suspicious money transfers in the account. According to federal surveillance reports, Spitzer shelled out over \$15,000 for seven or eight escort agency women over a period of half a year. He must have needed escorting badly. Did things improve during the time he was Attorney General and Governor after that? They did for his prostitutes, who pocketed up to \$80,000 of Spitzer's money over several years. So, you have to admit that at least while in office, he contributed to higher employment though, granted, it focused almost exclusively on a very specialized area of the working world.

Despite his own hobby in using prostitutes, Spitzer forged ahead and prosecuted accused prostitution rings during the time he served as Attorney General and head of New York's organized crime task force. Of course, no one realized at the time how much first hand knowledge Spitzer had of his target businesses or more accurately, first gland knowledge. Yes, in a textbook definition of the word "irony," Spitzer was paying for prostitutes for himself at the same time that he was targeting prostitution rings to shut them down. Talk about nerve. Talk about skating on thin ice. But, wait it gets even better. One of the escort services, NY Confidential, was run by a guy named Jason Itzler, who met Ashley Dupre, Spitzer's subsequent "escort," in 2004. Due to her skills in the service sector, Ashley was, of course, working as a cocktail waitress. Soon, she took her service skills to a whole other level, working as an escort for Itzler, under the name Victoria. Queen Victoria must have been spinning in her grave. In 2005, it became harder for Itzler to run NY Confidential for one good reason; the New York State Attorney General's Office closed it and sent Itzler to

prison. But, ever resourceful, Dupre managed to find gainful employment with the former CFO of NY Confidential at his new Brooklyn escort business, Velvet Traces. All this experience prepared Dupre to go on to achieve notoriety as Spitzer's gal at the Emperors Club VIP.

Threats of impeachment by New York State legislators motivated Spitzer's appearance, on March 12, 2008, to announce he was resigning as Governor. So, in just a few short months, Spitzer went from holding an important post, to being tied to a bedpost, to resigning his post. In his resignation speech, Spitzer said, "I go forward with the belief, as others have said, that as human beings, our greatest glory consists not in never falling, but in rising every time we fall." Reached for comment, Ashley Dupre confirmed that she had, in fact, experienced Spitzer rising many times.

Spitzer declared his candidacy for New York City Comptroller on July 7, 2013. Spitzer stated that he was hoping to be forgiven by the voters. "Like most men, I occasionally have let my little head make the decisions instead of using my big head," Spitzer might have said if he was totally honest. Manhattan Borough President Scott Stringer defeated Spitzer in the Democratic primary election on September 10, 2013.
