HOLLYWOOD EXPERIENCE SUMMER INTENSIVE TERMS, CONDITIONS, and GENERAL INFO

***Voluntary Participation:** I acknowledge that I have voluntarily applied to attend the Hollywood Experience Summer Intensive located at The Rage Entertainment Complex, 16911 Devonshire St., Granada Hills, CA 91344, and its affiliated locations which I may visit from time to time and utilize facilities, equipment or services therein.

*If Participant is a minor, I/We, the undersigned parent/guardian or Participant (hereinafter, "I"), hereby consent to the participation of the minor to attend classes at Hollywood Experience Summer Intensive (hereinafter, "HE").

***Meal Time:** It is expected that all students will bring a sack meal(s) and stay on our premises during mealtime unless accompanied by a parent or guardian.
