a) Minutes of September 10, 2015.

Staff recommendation: By consensus, accept minutes of September 10, 2015. On a motion by Commissioner Inscore, seconded by Commissioner Holley, and unanimously carried the Del Norte Local Transportation Commission approved the minutes from September 10, 2015.

b) US Congressman Huffman partnership contract for Last Chance Grade

Proposed Action: By polled vote, authorize execution of contract with U.S. Institute for Environmental Conflict Resolution, a program of the Udall Foundation, to address potential improvements on US Highway 101 at Last Chance Grade.

Ms. Leighton commented this contract continues our work with Congressman Huffman and that the work product is similar to the prior work. Commissioner Holley asked how would

this be funded. Ms. Leighton answered that it is already in the Overall Work Program and is funded with RSTP (Regional Surface Transportation Program) funds.

On a motion by Public Advisory Member Tucker, seconded by Commissioner Inscore, and unanimously carried on a polled vote, the Del Norte Local Transportation Commission approved the U.S. Institute for Environmental Conflict Resolution (US Congressman Huffman partnership) contract for Last Chance Grade.

c) Discussion items

- Cautionary speeds on Highway 101- Public Advisory Member Tucker handed out
 a flyer regarding advisory signs in response to questions from Commissioner
 Howard about sign changes on the Crescent Hill section on US Highway 101. Mr.
 Tucker noted that the signs are updated under the new standard. Commissioner
 Howard expressed concern about out of town drivers being surprised by the
 extreme curves and he thanked Mr. Tucker for the information provided.
- Pedestrian access on Highway 101 in urban area- Ms. Leighton commented that the Local Transportation Commissioner has been prioritizing pedestrian access on Hwy 101 for over 9 years and that she has been providing information to help answer questions about ADA access and how people who are in need can make a request. Chairman Murray commented that she appreciated Ms. Leighton's work in helping the community find solutions to this longstanding need.
- City ATP State-Only funding for Sunset Circle- Ms. Leighton reported that the City received an \$800,000 allocation of ATP funding for Sunset Circle. Ms. Leighton noted that the application in the approximate top 3% of all submitted. Ms. Leighton encouraged everyone to keep applying for this funding.

• The following Commissioner(s) commented on the following topics: Chairman Murray commented that Commissioner Inscore and she attended a meeting and one of the suggestions brought up was to televise the Del Norte Local Transportation Commission meetings and Ms. Leighton was directed to see how much it would cost to do this.
