On October 30, I met with Cathy Bryde, the parent/student advisor at Sexton, to talk about possible projects that the Board could work on jointly with Sexton students, parents, and

Cathy only suggested volunteering at events such as school dances and helping with parking for the football playoff games. If anyone in the neighborhood wishes to volunteer, then he/she must complete the school's volunteer forms. We also talked about having Sexton students help with planting the trees in the neighborhood in March. Cathy thought that perhaps the Science Club or the National Honor Society would be interested in helping, and she seems optimistic about this possibility.

I will be attending the Sexton PTO meetings, which take place on the 2nd Tuesday of each month.

We also seem to be at a standstill with the school doing much to address the issue of students in the neighborhood after school.

Annual Meeting:

I don't have much to report yet. The annual meeting sub-committee perhaps needs to meet again to finalize a few plans.
