#### **CALL TO ORDER**

Cunningham called the meeting to order at 6:33 P.M. Quorum reached at 6:35.

#### **GUEST PRESENTATIONS**

Pastor Brent Hale of the World Harvest Outreach Church along with his wife Rosemarie and church administrator Jamie Hildenbrand stopped by to introduce themselves to the board. The church has been in the neighborhood since 2000 and is located at 232 North Verlinden Avenue. It is a non-denominational independent congregation. Pastor Hale would like to become more connected to the neighborhood. Church members helped with the tree planting and they would like to continue to volunteer their services for those types of projects. It was suggested that they also might reach out to the neighborhood through an ad or announcements in the newsletter and on other WNA media.

## TREASURER'S REPORT

- Boehme is working on drafting language to amend the financial policy so that the board doesn't have to vote on small budget overages.

#### **FIESTA**

- The date is set for October 5.
- Casavant is meeting with the Irish Pub owner on May 20 and then meeting with Hecksel and Boutell on May 27 or 28. If there is still doubt about the Pub opening at that point, we will go with the Nuthouse for this year's Fiesta.
- Boutell reminded the board that we each need to sell 10 tickets.

#### YARD SALE

- The date is set for June 27-29.
- As of this point, 11 households have signed up, 8 from WNA and 3 from Old Oakland.
- Publicity: Cunningham will keep bumping the announcement up on the Facebook page so people see it. An article will appear in the summer newsletter and ads will be placed in local papers.
- A map will be given to shoppers so they can easily find the participating houses.
- Cunningham needs volunteers to help the day of the sale to pass out maps and put up signs.

## **GRANTS**

The Lenawee street sign is ready, though it hasn't been installed yet. There is no update on the Letts library project.

#### RIDDLE ELEMENTARY SCHOOL LIAISON

Fauson met with PTA member and neighborhood resident Jen Knapp Long. Based on that conversation, it seems that most of the school's needs are being met by the PTA. Fauson plans to speak with Casavant regarding the direction this position might take for the 2014-15 school year and/or whether this is a necessary board position. Knight suggested that Fauson contact the Lansing Public School District's community liaison and passed along contact information.

#### **SEXTON HIGH SCHOOL LIAISON**

- The Sexton High PTO and staff appreciated the breakfast provided by the WNA during Teacher Appreciation Week.
- The PTO is planning to hold a fundraiser in the fall and we might be able to support them.
- Boutell offered the newsletter as a means of communication for Sexton High community or news announcements and also suggested that Sexton can place ads in the newsletter to advertise some of their events.

#### **NEWSLETTER**

- Boutell and Boehme reached consensus on how to report advertisement revenue. The revenue from multi-issue ads will be spread over the year.
- Due date for the next newsletter is May 25. It will be out a week to ten days earlier than normal.

## **VOTER EDUCATION/CIVIC ENGAGEMENT**

Kovacik is planning to meet with Lansing City Clerk Chris Swope to develop a game plan for voter education.

#### **SUMMER EVENT**

- Westside Neighborhood Picnic is from 5:00 to 6:30 on July 16 at St. Joe Park. This is the same day as the Concert in the Park, which begins at 7:00.
- Attendance will be managed by asking neighbors to sign in with name, address, number in party, and e-mail. Each neighborhood member will receive a ticket. This will also allow us to collect updated contact info. We'll also have the map we use at the annual meeting there for neighbors to place their pins.
- Promotion will be via e-mail, Facebook, NextDoor, and newsletter, and RSVPs will be requested on the same. Hopefully this will give us a ballpark figure for attendance.
- Menu—Hot dogs, hamburgers, veggie burgers, some type of side salad, chips, watermelon, lemonade, and water. Condiments will be provided for the burgers.
- Entertainment—Stevens will lend some carnival games (small, portable) from Lansing Parks and Recreation department. We will need volunteers to man the games during the picnic and concert. Fauson's neighbor Russell Nebelung has accepted the invitation to play his guitar at the event for a sing-along.
- Stevens and Casavant still need to determine the location of the picnic set-up.
- We are planning on contacting Joe Duris, President of Old Oakland, to see if Old Oakland would like to be invited. If so, we are planning on asking for a \$1.00 donation per Old Oakland resident. It was also suggested at the board meeting that rather than collect money from individual residents, Old Oakland could cut us a check so that we wouldn't have to handle money.
- Stevens will provide Lansing Parks and Recreation Concert in the Park posters for us to hang at local businesses.
- Kovacik offered to contact Better Made and Koegel to see if we can get some food donated.

Payne moved (seconded by Kovacik) to appropriate \$15 for a 50/50 raffle license to be used during the July 16 picnic and concert.

#### **CRIME AND SAFETY**

- Boutell inquired about the School Watch fliers that residents are supposed to receive.
- Payne brought maps of the Lansing Police Department reorganization and described the plan. The LPD is allocating more officers to high crime areas and times in the city. More officers will be on duty during late night hours because those are higher crime times. This is a worry for School Watch.
- The Welcome to the Westside sign is done. The site is marked off and being prepared for installation. The unveiling date is still TBD. Payne plans to leaflet the houses of the surrounding streets to notify them of the unveiling event. Neighborhood children attending the event will be invited to bring and plant a flower at the base of the sign.

## **COMMUNITY ENGAGEMENT**

Alicea is interested in organizing a plant and seed exchange in the fall as people are thinning out their gardens. A gardening demonstration could be part of this event.

## **NEIGHORHOOD IMPROVEMENT**

We have 146 new trees in the neighborhood. Holland asked that board members keep an eye on trees over the summer for trees that aren't being watered.

#### PARKS AND RECREATION

The St. Joe Park clean-up went very well with about 16 people helping out. The city picked up all the trash on Tuesday and were very appreciative of our work. Stevens would like to thank all who helped, including the rugby team who uses the park.

#### **MLK GARDEN**

The garden is shaping up nicely for the year. We've had lots of interest from new gardeners and lots of help from the Land Bank and the Garden Project, including deliveries of wood chips and compost to the site. Four apple trees have been added to the site and we hope to add more fruit trees next year. We are exploring options for building a shade structure that could also be used for harvesting rainwater, and may be asking the WNA board if it would be willing to contribute to the purchase of building supplies.
