The Club aims to foster meaningful relationships among all alumnae through both social and professional activities.

President's Report

Katherine Axt '01 President

I am proud to present this report on another successful year of the Mount Holyoke Club of New York City. The board organized a variety of events for alumnae to enjoy this year, from cultural to health & wellness to career events. These events would not have happened without the hard work of the board, which is described in this report. I am particularly pleased that we saw an influx of new alumnae—from all graduating years—attend our events, and of course, this report would not be complete without a proper nod to our crowning achievement, the Vespers concert and fundraiser.

Besides organizing programs for our members and other alums to enjoy, the Mount Holyoke Club of New York City raises money for the Alumnae Scholars program. As is tradition, this year we are able to offer a \$12,500 (\$11,500 from Vespers and \$1,000 from membership donations) scholarship to a current student. In addition, the Club's donation of \$50,000 to the endowed 1949 scholarship continues to grow interest and support a second student yearly. I would like to thank all of the alums who made gifts to the Alumnae Scholars program. We are very proud to be able to make this contribution and to ensure that Mount Holyoke students receive additional financial support each year.

I recently spoke with Alyssa Nelson '11, one of our current alumnae scholarship recipients from Washington Heights, to get an update on her plans. Alyssa is a graduating senior majoring in sociology with a minor in educational studies. She will be attending the University of Massachusetts Dartmouth for law school in the fall, and she just completed an independent study on juvenile delinquency in Holyoke, MA, among Puerto Ricans. Alyssa performed community service in a youth detention center all four years while at Mount Holyoke, which spurred her interest in becoming a juvenile justice/criminal defense attorney. While at Mount Holyoke, she was also active with the Association of Pan African Unity. Alyssa expressed that she is very grateful to the Club for the scholarship, as she would not have been able to attend Mount Holyoke without it.

The Office of Development also shared that our endowed scholarship fund recipient, Catherine Braine '11, is a biology major and psychology minor, also from New York City. She just completed a senior thesis, working with transgenic flies to assay the effects of the knock out of the Pink1 protein in muscle tissue, a project which utilized both molecular biology methods and transmission electron microscopy. Catherine also worked this year as a lab instructor for Developmental Biology and is now applying for jobs with the hopes of obtaining a lab technician position for a few years before pursuing a graduate degree. Outside of the classroom, Catherine continued to serve as Vice President of the Mt. Holyoke College Democrats and public relations representative for the Mt. Holyoke Pre-Medical Association.

It is success stories like Alyssa and Catherine's that make our work with the Club all the more meaningful. I have had the honor and the pleasure of serving as your President these past three years, as well as the role of Treasurer and Alumnae Admissions Representative before that, and

it is with sadness that I close a wonderful chapter on my Mount Holyoke volunteering life to pursue graduate school. You will be in wonderful hands with new president, Tara Paone '81, however, and won't be disappointed! Tara and I have worked closely together for the past three years, and I look forward to hearing about the new endeavors she has in mind for the Club and participating on the member level rather than on the organizational side.

In closing, I would like to thank the entire board of the Mount Holyoke Club of New York City for its commitment to the mission of the Club. Furthermore, I want to express our sincere gratitude to those alumnae who chose to become Club members and others who supported our programming efforts. Lastly, we must thank the staff and faculty of the college and the Alumnae Association who helped to make this a successful year.

<u>Treasurer's Report</u> Fiscal Year 7/1/10 to 6/30/11

Dana A. Barta '04 Treasurer

Overview

We started the year with about \$42,000 in our account. We expect to close the year with approximately \$53,500 after we deduct remaining anticipated expenses and the Scholarship payment.

Revenue

This year, the Club received income of approximately \$64,500. These funds came from Vespers, membership, other events and interest income. Net proceeds from the past Vespers was over \$23,000. Membership contributions totaled approximately \$4,600. Contributions ranged from young alumna membership of \$20 to amounts in excess of the patron level membership of \$150. Alumnae are welcome to make contributions in any amount above the membership price of \$40. All amounts over \$40 are put into the Alumnae Scholarship fund. \$1,000 was contributed by members to the Alumnae Scholarship this fiscal year. Revenues from various club programs other than Vespers were in excess of \$6,000. The club will donate a total of \$12,500 towards the Alumnae Scholar.

Expenses

Fees from the Club's programs (excluding Vespers), typically charged to cover program expenses such as catering and room rental, totaled approximately \$6,500. Vespers costs this year were approximately \$30,000. The Club's operating expenses of approximately \$3,200 are primarily related to the cost of communications, email distribution, mailbox rental, voicemail box, annual meeting costs and board meetings. As mentioned above, the Club will donate \$12,500 towards an Alumnae Scholar, \$1,000 of which was donated through membership.

Planning and coordinating the events along with the Program Committee and the Young Alumnae Committee, the Seven Sisters representative tries to foster the relationship with the Sisters Colleges; currently the active club members are Wellesley, Smith, Bryn Mawr and Barnard. This was a quiet year for the Young Alumnae Committee. We did not host any events specifically targeted to the Young Alumnae population in NYC.

On a more positive note, several young alumnae had the opportunity to attend the Vespers pre-concert reception thanks to the generosity of Kristen Kelly Fisher '90.

For the upcoming year, the focus will be on reviving the bi-monthly happy hours. We have had trouble getting a good response to Happy Hours hosted in the past and one suggestion has been to organize the Happy Hours on Thursday vs. Friday. Mount Holyoke Young Alumnae Club of New York (MHNYCYA) – The Young Alumnae Facebook page has been up and running for over two years. We had 28 members join over the past year bringing the number of members up to 207. The MHNYCYA Facebook page has served as a great tool, enabling the board to make announcements, post club events, photos, and keep the group up to date, while the group members are using it as a discussion forum with posted items about City events, recruiting, moving sales, rides to our Alma Mater, etc.

Maria-Stella Fountoulakis '99 and Abigail Wolff '82 continued using **MyEmma** this year to handle the Club's emailed communications, including both our Mount Holyoke Club of New York monthly newsletter and periodic event reminders. As of June 1, our email list contains 1,104 active email addresses, a number that includes both paid members and other alumnae who are interested in Club announcements. The number of emails on our list has remained steady over the past few years. We send emails to those on our mailing list approximately twice per month; newsletters and other announcements/reminders about upcoming Club events are the most common types of correspondence. Over the course of this academic year, we sent out a total of ten newsletters and six event reminders. We continue to discuss possibly incorporating all NYC area email addresses from the Alumnae Association, but have hesitated due to time and cost commitments involved with this.

MyEmma also allows the Club to track the success of our online communications by viewing the number of emails opened, new members who join after being forwarded one of our emails, and the most popular links in each of our email communications. We have good open and click-through rates for our messages, with an average open rate of 27.9% compared to a nonprofit industry standard of 27.6%, and average click-through rates of 5.3% compared to a nonprofit industry standard of 4%.

The Club continues to use the Gmail account <u>mountholyokeclubofnyc@gmail.com</u> and also implemented a new club phone number this year through Skype online to reduce costs: 347-408-0821. Access to these accounts is given to members of the Club's Executive Board, but the Communications Co-chairs regularly check both for messages.
