**ORDER DENYING PRELIMINARY

On June 1, 2012, the Court heard argument on Petitioner Save The Plastic Bag Coalition's motion for preliminary injunction. Having considered the submissions of the parties and the argument of counsel, the Court rules as follows:

Petitioner's motion for a preliminary injunction is denied. The showing of harm is vague and speculative. The Court finds that Petitioner has not shown that the environment, the public interest and Petitioner's members would suffer harm from the denial of the injunction.

For the foregoing reasons, Petitioner's motion is DENIED.


