 - A. A request for special use and zoning for a business operating in a two-flat on Ashland was withdrawn.
 - B. A question was asked about zoning restrictions based on height or size because of a property on Gregory.
 - 1. The height limit is 30 ft. Based on RS3 zoning (previously RS4).
 - 2. A request was made to investigate the property at 1619 Gregory
 - 3. A request was also made to investigate an occupied foreclosure at 1620 Gregory.
 - C. A questions was asked about construction at 5434 N. Clark.
 - 1. Construction is waiting on better weather.
 - 2. Land Use and Zoning has looked at the property.
 - D. A question was asked about 5441 N. Ashland having no permits.
 - 1. The property will be investigated.
 - E. A question was asked about Edgewater Medical Center being sold for single family housing.
 - 1. The property has not been sold.
 - 2. The single family housing is only a proposal being made.
 - 3. A question about medical waste was raised.
 - a) The site will have to meet requirement and involve environmental mediation.
 - F. A question was raised about whether we would be notified about the train station at Peterson and Ravenswood.
 - 1. WANT has been involved in this discussion.
- V. Trumbull Elementary
 - A. There is not much news to report.
 - 1. The last news report indicated that CPS plans to reuse the building.
- VI. The Garden
 - A. As the Garden ages it requires more expense to care for and repair.
 - 1. We budgeted \$500 for this next year.
 - 2. We will be rechipping the path.
 - a) This happens every other year at the end of April.
 - b) The Garden committee requests any available help for this project.
 - B. We will be cleaning the are between the fence and the Metra tracks.
 - 1. We were granted permission to do this.
 - 2. We also received a \$500 donation toward the effort.
- VII. Rogers Park Montessori traffic report
 - A. President Fick met with the Alderman, the school, Bomanville representatives and a representative from CDOT.
 - 1. Any left turns are deemed to be unsafe and not an option.
 - 2. They proposed a 2:30–4:00 p.m. parking ban on Ravenswood. Between Balmoral and Catalpa.

- a) This is not optimal based on what our organization wants.
- b) Pauline's was contacted about it.

- C. Debby's Pope proposed that suggest they park on Wolcott and then be released onto Bryn Mawr then onto Ravenswood toward the school, eliminating waiting on Ravenswood without causing left turns.

VIII. Expansion of Passages Charter School

- C. They have a letter of support from St. Gregory's Priest based on
 - 1. Potential improvement of the neighborhood.
 - 2. Benefit to the immigrant community.
 - 3. Belief that traffic problem has improved.
- D. The vote will be held in January
- E. Alderman Osterman does not support the expansion.
- F. Senn High School also does not support the expansion.
- G. Comments and discussion was held.
- H. President Fick said that WANT needs to have a position on this issue based on our neighborhood values.
 - 1. Passages would affect current neighborhood high schools.
 - 2. Traffic problems in that area would be exacerbated.
- I. A vote was held for WANT members only.
 - 1. The membership voted to oppose the expansion and write a letter explaining WANT's position.
 - a) There were two abstentions.
 - b) There were no votes in support of the expansion.
