# 7. DEPUTATIONS

a) Debra Murphy of Cowan's Insurance and Mike Airhart of Grants Insurance will discuss the additional insurance coverage on the 2013 municipal insurance policy

Debra Murphy reviewed the following:

Municipality liability limit (\$25,000,000 coverage per claim, with multiple coverage, no aggregate limit).

Third party claims deductible of \$10,000.

Forest Fire coverage has been added to our policy to cover property damage resulting from the incident if by provincial order, we must pay.

Wrongful Dismissal of up to \$250,000 for lawyer's fees (\$5,000 deductible) does not pay damages.

Errors and Omissions up to \$25,000,000 coverage. Claims made form, which means each claim is in its separate 12 month policy coverage and written notice for such is required.

Non-owned automobile coverage up to \$25,000,000. Own policy responds first, then the municipality responds afterwards.

Environmental Policy (dump sites) up to \$2,000,000 per claim up to a maximum of \$4,000,000 term policy.

Council requested that the Clerk, Debra Murphy and Mike Airhart meet to discuss the insurance ramifications of the 2008 house fire, which had the municipality incur \$160,000 in clean up costs.

Crime (forgery, fraud etc) the money and securities is \$200,000 coverage

Board member policy coverage for accidental death and dismemberment of up to \$250,000. Council could also add coverage 24/7 for an added premium per member. Critical illness is covered as well.

Council requested a costing for 24/7 coverage for accidental death and dismemberment and critical illness coverage.

Accidental death and dismemberment of up to \$100,000 coverage

Conflict of interest pays 100% of legal with a maximum limit of \$100,000

Legal fees \$100,000 or up to \$250,000 per coverage year. Coverage defense for Criminal Code.

Property coverage \$2,500 deductible. Break down of equipment

Automobile policy – \$25,000,000 policy with \$2,500 deductible Transit -\$10,000 deductible

Volunteer coverage – \$750 per year for up to 200 volunteers with a maximum coverage value of \$50,000 for them personally( death, dismemberment up to the age of 80)

Gary McDonald, a resident at Thomas & Green Streets in Deseronto, presented some concerns shared by him and neighbouring residents regarding the community. He expressed concern over the lack of accessibility in the form of a ramp/lift for disabled individuals.

Councillor Tumak responded that the Town hopes to address the issue this year, and has a requirement to comply with provincial regulations by 2014.

The Town will have to address many other issues as part of the installation of accessible options which will incur significant costs.

The issue will be addressed in the 2013 municipal budget. Mr. McDonald inquired as to who is responsible for preparing the municipal budget. Councillors Tumak and Johnston responded stating that all department supervisors and Council chairs are responsible for submitting municipal budgets which are passed by Council.

Mr. McDonald requested confirmation of the date the issue will be addressed. Councillor Tumak responded to say the issue is a 2013 priority.

Mr. McDonald expressed concern over the noise that the water/waste water plant has been emitting over the past week. The noise is from mechanical blowers used to supply air for the water treatment process. There are 3 blowers, recently one of the 2 main blowers was taken out of service for repairs and the back up blower was turned on. Turning this one particular blower on is creating a more excessive noise as a result. The noise should be dispensed with totally by 2013 as part of the plant upgrade project.

Mr. McDonald expressed concern over vehicles not adhering to the posted 40 km/hour signs posted throughout the municipality. He is suggesting that the municipality consider installing additional signs that are neon in colour and stating something to the effect of "This is a 40 km zone, children at play". The item was deferred to the Public Works department chair for further review.

Mr. McDonald felt that OPP coverage needs to be more under cover then uniformed.

Mr. McDonald inquired as to a caution light being installed at Centre and Dundas Streets and why the sidewalks are not cleared in the municipality by municipal workers.

Gary McDonald inquired as to street parking on public streets, which will be towed or ticketed for additional revenue.

Mr. McDonald commented that four wheelers and street bike operations on the streets are unsafe and are causing concern for area residents.

Mr. McDonald commented that Deseronto Transit should offer new driver training and operate on a 5.5 - 6 day schedule and not
