Option 2 entitled "Hastings-Belleville-South Lennox & Addington" which Includes all of the fourteen member municipalities of Hastings County, the whole of the City of Belleville and the Town of Greater Napanee and Loyalist Township in the County of Lennox & Adddington along with the new riding of "Frontenac-Lanark".
