c) Entrance at Bayview

Councillor Johnston brought forth a concern by a property owner due to the conditions of their entrance. The property owner believes that the deteriorated area is town property and is contributing heavily to the "washout" on his property.

Councillor Johnston asked that Joe Carter be requested to look into this matter to determine whether this concern is valid and if it is, rectify the issue, and if it's a private matter to inform the property owner.
