7. DEPUTATIONS/PETITIONS -

a) County Warden, Ron Emond

Warden Emond informed Council of his election as the chair of the Eastern Ontario Warden's Caucus and a director on the AMCTO Board.

The warden apologized for his absence of the Mayor's Levee. Updated Council that the Eastern Ontario Wardens Caucus is looking into getting broadband, and there are an outstanding 20 responses to the request. In early March the initiative will step into the financial funding initiatives.

Other areas of concern are social housing, and he expressed the concern that 18,000 are on the list for social housing.

Roads and bridges is another area of concern for the caucus and are pushing for a seat on the fiscal review. They are trying to address, crown lands, seasonal residences, and 911 initiatives.

b) Inspector Pat Finnegan, O.P.P

Inspector Finnegan submitted and reviewed the November-December 2008 Police Services Report. Informed Council members that it is the OPP's intent to report to Council every two months to present this report.

c) Terry Kimmett

Informed Council of his concerns that there Is more activity at the Quarry over the past week. Has informed the OPP that he would like every individual on the property charged with trespassing. Addressed some concerns about tax issues on his property and his inability to use his land. Expressed concerns of discrimination. Approximately \$6600.00 in damage in Deseronto and the Tyendinaga losses are in the millions of dollars ranges. Has given the Town of Deseronto an invoice of \$6,600 for losses as claimed by the property owner from 2007 and 2008.

Councillor Tumak has suggested that we arrange a meeting with Terry Kimmett with the MP and MPP

The Mayor believes that we must demand a meeting with the Indian and Northern Affairs Minister.

Warden Emond requested that Mr. Kimmett gather the information and submit this to the Mayor. The County will request a meeting with ministers at higher levels to help garner support for the initiative.
