7.1 Robert Keene from Infrastructure Ontario

- R. Keen e provided Council members with an update on Infrastructure Ontario, including the following items:
 - Ministry change to Energy and Infrastructure
 - Loan structures: construction loans (short-term with low interest rates e.g. 2.56%), serial loans (larger up-front "costs"), and conventional long-term loans (locked in for term of loan, fixed rate over term of loan and regular by-annual payments)
 - Time frame from application to approval: maximum 6 weeks due to requirements for Council to pass by-laws
 - Types of projects eligible for financing: construction, land purchase, equipment
 - Types of eligible organizations include Municipalities and wholly owned Municipal Corporations (with some restrictions)
 - Once a financing agreement is approved, the organization has one (1) year to use the funds (or begin using the funds)
