They are going to bring the waterfront plan in the Official Plan, and if an earlier date is desired we could draft an amendment at an earlier date if needed. The timeframe for an amendment is between 3-6 months for completion. Mr. Walsh will try and get an up to date status report to better inform Council as to the status of the completion of the Official Plan.
