Redistricting

Leagues in Kentucky and other states are speaking out about the manner in which redistricting has been handled. On January 31, Franklin Circuit Court Judge Phillip Shepherd extended the filing deadline one week for legislative candidates in response to a legal challenge to district boundary lines adopted by the Kentucky legislature.

LWVUS policy states: The League of Women Voters of the United States believes that voting is fundamental citizen right that must be guaranteed.

AND The League of Women Voters of the United States believes that congressional districts and government legislative bodies should be apportioned substantially on population. The League is convinced that this standard, established by the Supreme Court, should be maintained and that the U.S. Constitution should not be amended to allow for consideration of factors other than population in apportionment.

Watch for discussion of this as a state issue at the Spring Council meeting.

The League of Women Voters Supports: Restoration of Felon Voting Rights - HB 70

HB 70 proposes amending Section 145 of the Constitution of Kentucky to allow persons convicted of a felony other than treason, intentional killing, a sex crime, or bribery, the right to vote after expiration of probation, final discharge from parole, or maximum expiration of sentence. If passed, this amendment would be placed on the ballot this fall for voters to ratify or reject. Clean Energy - HB 167 and HB 187

HB 167 would encourage greater energy efficiency, conservation, and the use of renewable resources in order to promote energy independence and security by diversifying the portfolio of energy sources used for generating electricity for Kentucky retail electric customers; encourage economic growth; create high-quality jobs, training, business, and investment opportunities in the Kentucky energy sector; determine energy forms and sources that qualify as renewable energy; set specific obligations to achieve specified increases in the applications of various renewable energy forms and to increase the efficiency of electric usage through targeted low-income weatherization programs and Kentucky state energy programs; provide for alternative plans for public utilities and city-owned or city-controlled electric generating facilities by offsetting reductions in energy use and increased efficiency of use; provide for Public Service Commission denial of issuance of certificates for public convenience and necessity for new or expanded conventional generating capacity for utilities that fail to fulfill their obligations to diversify energy sources and increase efficient use of energy; specify reporting requirements and intervals to the PSC regarding progress in diversifying energy sources and increasing efficient use of energy. Clean Judicial Elections - HB 230

HB 230 would establish the clean judicial elections fund for distribution to certified judicial candidates administered by the Kentucky Registry of Election Finance; require the registry to publish information about campaign expenditures in the judicial campaigns of the previous year; establish candidate requirements to qualify to receive funds; provide that a person entitled to a state tax refund may designate on their income tax return an amount to be credited to the fund; allow members of the Kentucky Bar Association to contribute to the clean judicial elections fund with their bar dues.
