Notes

- Tenant floor plans are 97% complete with the exception of the imaging suite, PLN to forward backgrounds after meeting and consultants will start their designs.
- PLN to forward imaging equipment specifications from a previous project for consultants to utilize in establishing their designs with the understanding there will be minor adjustments once we receive the actual equipment specifications that will be utilized.
- Sub-panels for imaging to be located within the imaging equipment room (129) if there is adequate space. Alternate location for sub-panels may be the vestibule (113).
- Jason Perry asked if they were responsible for lighting controls, Layman typically includes with their design. We will move forward with Layman including in their design with the intent to further discuss the benefits associated with Emcor including in their design.
- House panel not needed as we are utilizing a single metered main service. Exterior lighting will be tied into a tenant's sub-panel.
- Physicists report will need to be commissioned by imaging tenant as a requirement of completing design.



- Geo-tech is scheduled with a final report expected within 4-6 week, Cal Mill to get field report prior to that in an effort to expedite their design.
- Physical Therapy tenant has no concern with a post in the middle of their space.
- Digital copies of the Civil design from the 1st project are not available, Gordon to track down the physical set and forward for use.
- Fire sprinkler water supply likely to be 6" with a 4" riser.
