## HON. DAVID EBY Q.C. ATTORNEY GENERAL OF BRITISH COLUMBIA

An award-winning human rights lawyer, David Eby is the MLA for Vancouver-Point Grey, first elected in 2013. In July 2017, he was appointed to his current role as Attorney General. David is also responsible for Gambling policy, Liquor policy and the Insurance Corporation of BC (ICBC) for the province. Previously, he was the Executive Director of the BC Civil Liberties Association, an adjunct professor of law at the University of British Columbia, the President of the HIV/AIDS Legal Network, and served on the Vancouver Foundation's Health and Social Development Committee.



## DR. MICHAEL ZAJKO

Dr. Mike Zajko is an Assistant Professor of Sociology at the University of British Columbia's Okanagan Campus in Kelowna. He received his MA in Sociology at the University of Calgary, and his PhD at the University of Alberta. Dr. Zajko teaches courses in criminology, social theory, statistics, and Canadian society. His previous work, published in journals including Society, the Canadian Journal of Communication, and the Canadian Journal of Law and Society, has examined various forms of governance, regulation, and law-breaking, particularly in regards to internet policy and the Canadian telecommunications industry.

### **ARCHIE ALAFRIZ**

THREAT FINANCE MITIGATION SPECIALIST,
AML/CFT COMPLIANCE, FINANCIAL INTELLIGENCE, COUNTERPROLIFERATION



Archie Alafriz served 27 years with the RCMP, 14 of those were with the Anti Terrorist Financial Investigations Unit of the Integrated National Security Enforcement Team. He was the lead investigator in a Canadian landmark terrorist financing investigation. Archie was seconded to the BC Securities Commission and then the Joint Illegal Gaming Investigation Team of the Combined Forces Special Enforcement Unit. He investigated money laundering typologies in casinos, real estate and the money services business (MSB). He created the Joint Financial Intelligence Group, a multi-agency ensemble that liaised across critical industries to provide a financial threat screen in advance of the 2010 Winter Olympics in Vancouver. Moreover, Archie developed the Eastern Financial Threat Paradigm and provided the necessary training to law enforcement and partner government agencies.

## JAMES COHEN EXECUTIVE DIRECTOR, TRANSPARENCY INTERNATIONAL

James is an international development expert with a background focusing on anti-corruption and security. James' work includes program management and design, training, research, and fundraising for organizations including the United States Institute of Peace, the African Centre for Justice and Peace Studies, the Global Organization for Parliamentarians Against Corruption, and the Geneva Centre for the Democratic Control of Armed Forces. James also worked for Transparency International's Defence and Security Programme from 2011-2013 where he focused on corruption risk to military, police, and peacekeeping.
