Dog Beach Hours: Friday, Saturday & Sunday, 3 p.m. - 7 p.m.

- Dogs permitted in designated beach area only.
- · Dogs shall be on leash at all times except in designated area. Owner must carry leash at all times in the dog beach
- You are responsible for immediate disposal of all fecal matter deposited by your dog.
- Dogs should not create a nuisance by causing any form of disturbance such as excessive barking and other types of inappropriate behavior.
- The holder shall indemnify and hold harmless the City, its employees, officers, agents and assigns from any and all claims for injury and/or damages to property, including wrongful death, resulting from the use of this permit.
- Owners accept responsibility for the actions of their dogs.
- Female dogs in heat, aggressive and any dogs not up to date with required vaccines are NOT permitted.
- Owners must carry issued permit at all times when using the dog beach.
- Dogs are not permitted to dig in the sand.
- Dogs must have collar, name tag, and rabies tag on at all
- Limit two (2) dogs per owner.

NOTHING IN THIS AGREEMENT SHALL BE CONSTRUED TO AFFECT THE CITY'S RIGHTS, PRIVILEGES AND IMMUNITIES UNDER THE DOCTRINE OF "SOVEREIGN IMMUNITY" AND AS SET FORTH IN SECTION 768.28, FLORIDA STATUES.
