Speaking of Newsletters...Wait 'til You See How We Spice it Up!



I can not believe we are already more than half way through 2005! Where does all the time go?

As always, I would like to thank you for making not just the last 6 months, but the last several years such a great time to be in our neighborhood! Rather than using this space to solicit membership or money, I would like to take this opportunity to provide you with some neighborhood statistics as well as share some concerns I have with regard to our neighborhood.

Since 2001, our CHAP21 Neighborhood Association membership has grown from approximately 20 to over 90 households with well over 100 members! We have held at least one or more general membership meetings per year since 2001 with many folks attending to offer suggestions for improvement, and to express their concerns about where we live. Our neighborhood association financial picture is solid. Our long-awaited website has been launched! A minimum of two neighborhood newsletters have been generated each year since 2002. While we are not crime-free, violent crime has been non-existent within our boundaries. A number of neighbors have hosted various social events that have brought people together for fun and friendship. We live in a great place.

The above highlights having been stated, I also have my share of concerns. A number of people over the last several months have expressed concerns regarding general crime and quality of life issues. Many of you expressed these concerns when completing the form for your CHAP21 Neighborhood Association membership. A good number of you have been disturbed more than once by parties where loud music, screaming and yelling, public urination, drunk and disorderly conduct, littering, vandalism, illegally parked cars and the screeching of tires prevails. A large number of our neighbors (a larger number than you might think) have sold their houses and moved out of our boundaries to escape this problem. I heard just yesterday that yet another neighbor is planning on selling their home with the next year to get away from this behavior! Have you noticed the number of houses for sale in our neighborhood lately? Have you noticed the small number of houses that have been sold more than once in the last several years? In the last few weeks there have been a number of instances where people have been disturbed by the bad behavior of some of our younger residents, but in most cases the police were not called, nor was I contacted. I can only ask WHY NOT? Your well-being and peace of mind, not to mention your sleep is more important than your neighbors having fun! In most cases, they are breaking the law! Your Neighborhood Association can do nothing to help you unless you take that first step and contact us and the Rochester Police Department!

As stated in the body of this newsletter, back in January of 2004, I created a Nuisance/Crime Log and attempted to begin tracking these types of problems within our neighborhood. It was very effective in 2004 in dealing with several groups of young adults near my residence who had no respect for those around them as well as the Rochester Police Department, and it also reflected upon the landlord who tolerated their behaviors. I'm happy to say the number of times we have had to call the police was drastically reduced. This was not the case when I purchased my home in August of 1999. Every weekend from August through mid-December of 1999, either I or my partner Todd contacted the Rochester Police Department because of the behaviors mentioned above. During this period of time, we must have called 911 approximately 75 times! I began to question why I stayed in this neighborhood, having lived on Audubon Street as a renter since 1994. Slowly,

I began to realize that other neighbors around me were also troubled by the noise and disrespect, and we began to work together to combat the problem. We tried many approaches, but nothing worked consistently. Once we were able to put together our Nuisance/Crime Log in 2004 and recorded instances where city ordinances were being broken, it enabled to us to show the RPD the consistency of the events and how chronic the situation had become.

I am asking that we all work together to make our neighborhood a better place to live and sleep. If you have noise issues in your area of the neighborhood that are in violation of the city's noise ordinance, call 911! And then call us!
