The Story Writer understands that he or she has no rights to the recording or any benefits derived there from. Story Writer hereby waives any right of inspection or approval of his or her likeness or the uses to which the likeness may be put.

The Story Writer warrants and represents that he or she has the right to grant all rights granted herein and Producer's use of the Story as contemplated herein will not infringe on the rights of any third party. Story Writer will indemnify and hold Producer, its parent, successors, licensees and assigns, harmless from and against any all claims, damages, liabilities, costs, and expenses arising out of any breach of the foregoing warranty. Story Writer acknowledges that Producer will rely on this permission potentially at substantial cost to Producer and Story Writer hereby agrees not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder. In no event shall Story Writer be entitled to, and Story Writer hereby waives the right to, seek or obtain injunctive or other equitable relief that would enjoin or restrain the development, production, distribution, exhibition or other exploitation of the Story, the Productions, or any rights relating to the foregoing.
