ORDINANCE NO. 790 – 2016

AN ORDINANCE RELATING TO AMENDING THE
2015 CITY OF ALGOMA FEE SCHEDULE BY MODIFYING BOAT LAUNCH FEES

WHEREAS: The Common Council of the City of Algoma has the authority to promote the public health, safety and welfare pursuant to the general grant of authority to the City according to Wisconsin Statutes, Section 62.11 (5); and

WHEREAS: The Algoma Code of Ordinances states at "Section 7.13 CITY BOAT LAUNCH USE FEES. (3) The fee amounts shall be established annually by the Marina Committee."; and

WHEREAS: The Common Council adopted Ordinance 784 on May 4, 2015 creating Section 3.11 (1) of the Algoma Code of Ordinances which establishes the City's General Fee Schedule and by reference incorporates therein and makes as a part thereof **Exhibit A (the "2015 City of Algoma Fee Schedule")** listing the specific fees collected from the various ordinances, resolutions, and policies for the City established as of the effective date of this Ordinance; and

WHEREAS: Ordinance 784 provides for an annual review of the City of Algoma Fee Schedule; and

WHEREAS: The Marina Committee has reviewed the fees on the Marina portion of the City of Algoma Fee Schedule and recommends changes to those fees to cover sales tax that needs to be paid to the State of Wisconsin on fees charged at the Marina.

NOW, THEREFORE the Common Council of the City of Algoma does ordain that:

- I. Section 7.13 (3) of the City of Algoma Code of Ordinances is repealed.
- II. Section 3.11 (1) of the Algoma Code of Ordinances and **Exhibit A (the "2015 City of Algoma Fee Schedule")** as established thereunder shall be amended as follows:

a. Daily Launch	\$ 7.00	\$ 8.00*
b. Resident Seasonal Pass	\$50.00	\$60.00*
c. Non-Resident Seasonal Pass	\$70.00	\$80.00*
d. Seasonal Slips (per foot)	\$50.00	\$55.00*
e. Transient Docking (per foot)	\$1.25	\$1.50*

*All fees include sales tax payable to the State of Wisconsin.

- III. This ordinance shall take effect upon passage, posting and publication as provided by law.

Adopted by the Common Council of the City of Algoma, Wisconsin at a regular meeting thereof on the 7th day of January, 2016, by a vote of 8 for and 0 opposed.
