# Village of Los Ranchos de Albuquerque Facility Rules and Regulations



## Larry P. Abraham Agri-Nature Center Classrooms

The Larry P. Abraham Agri-Nature Center is located at 4920 Rio Grande Blvd.

Half of the building is comprised of three classrooms (two small and one main room), a kitchen, and a catering set-up area. There are two non-ADA accessible bathrooms, one male and one female. This side of the building has heating, cooling, electricity, wireless internet (signal is weak), a fire sprinkler system, and sinks with non-drinkable water. Occupancy is dependent on setup, but the main classroom can hold up to about 65 people. The kitchen has a fridge with freezer and two sinks available for use. The use of the stove and microwave is prohibited. Minimal kitchen utensils are available, renters must bring their own.

Moveable equipment in the building: 110 chairs, 8 rectangular tables, 9 round tables, 5 timber high tables for wine receptions, 1 projector, 1 screen, 1 large whiteboard.

There is a small building on blocks near the garden and parking lot. This is a historically significant home, the Schulte House, slated for preservation that is not included in rental. **Please do not touch or enter this building.**

To the west of the building is a demonstration garden and vineyard used for agriculture education that may be included in rental at the discretion of the Agricultural Programs Manager and may be limited to a staff-guided tour or demonstration. The open patio is included in rental.

Parking Lot B is unpaved with two (2) ADA parking spaces. It is the smaller lot that wraps around the building. This is included in rental.

The following rules and regulations apply to the use of the **Larry P. Abraham Agri-Nature Center Classrooms**:

- **Rental Fees & Security Deposit**

The fee is \$750.00 per day and \$375.00 per half-day for nonresident or for-profit entities and \$375.00 per day and \$187.50 per half-day for Village resident, Village business, or non-profit entities. In addition, a \$100.00 refundable security deposit is required. The applicant is responsible for preventing any damage to the facility and property during rental, as well as overseeing proper cleanup. The applicant is responsible for their own trash receptacles outside the building. The applicant may receive their security deposit back within thirty (30) business days after rental, after Village inspection.

Damages: No structural damage of any kind, including torn awnings, broken windows, damaged door mechanisms, and wall and floor damage. No damage to machinery, equipment, or furnishings. No damage to fields or growing areas of any kind, including

digging, significant trampling by foot or vehicle, or removal of existing plantings and their supports.

Cleanup: Elimination of any and all litter. Removal of applicant-provided furniture and equipment. Removal of all food, beverage containers, food/beverage spills, or droppings as a result of on-site food or beverage preparation.

- **Permissible Activities**

This facility is intended for agricultural education use only. On a case by case basis other permitted uses may be allowed at the discretion of the Village Administrator or Mayor. The Village retains the right to determine the appropriateness of a requested event and to approve or deny requests at its discretion. Alcoholic beverages are permitted with approved permits from the State of New Mexico Regulation and Licensing Department.

- **Fire Department Review**

If the activities proposed will involve an open flame or serving of hot food, the Village will forward this application to the Bernalillo County Fire Department for their review to ensure compliance with the International Fire Code. They will approve the locations and use of any heating or cooking equipment. A fire inspection may be required to ensure all life safety requirements are met. The use of propane is prohibited. Smoking is prohibited inside buildings and within 25 feet of any building. Occupancy load within the building will be determined by the floor plan that is submitted and approved. Any requirements from the Fire Department will be forwarded to the applicant as conditions of approval.

- **Parking**

Attendees are to utilize Parking Lot B on-site. Parking is prohibited on the fields.

- **Furnishings**

Applicants may bring their own furnishing and equipment. All equipment must be shown on the floor plan and approved by the Fire Department.

- **Food Preparation Equipment**

All food preparation equipment, furnishings, and appliances must be shown on the floor plan and approved by the Fire Department.

- **Liability Insurance**

The Village requires proof of liability insurance in the amount of one million (\$1,000,000) dollars per occurrence of general liability with the Village of Los Ranchos de Albuquerque named as additional insured on the policy as follows:

- **Cancellation**

If the applicant cancels the event within ten business days prior to the event, rental fees will be refunded and one-half of the security deposit will be forfeited except in weather related cancellations. If the applicant cancels the event at least ten business days prior to the event, all rental fees and security deposit will be refunded.


