**INSTRUCTIONS FOR ATTENDING MEETING WITH ZOOM APPLICATION
ON YOUR COMPUTER:**

- You will need to have the Zoom application installed on your computer (if you do not yet have it installed, it can be downloaded for free at zoom.us/download).
- If prompted to include a name, please use your first and last name (no nicknames).
- When you join the meeting, you will be sent to a waiting room until the meeting moderator allows you to join the meeting. Please **log into the meeting at least 15 minutes before the scheduled meeting start time** to allow the moderator enough time to let you into the meeting before it starts.

INSTRUCTIONS FOR ATTENDING THE MEETING BY TELEPHONE:

- To attend the meeting by telephone call any of the Telephone Dial-In numbers prior to the meeting start time.
- When prompted, enter the Meeting ID and you will be connected to the meeting.

INSTRUCTIONS FOR PROVIDING PUBLIC COMMENT BEFORE THE MEETING:

- The public may submit written comment prior to the meeting by physical letter to Village Hall (6718 Rio Grande Blvd) or email to Danielle Sedillo-Molina at dmolina@losranchosnm.gov **no later than 5:00 PM Wednesday, September 30** for inclusion in the meeting packet. Comments received after that date will be read aloud at the meeting.

You must include in the letter/email:

- Your first and last name
- Your full address

If you are commenting on a public hearing item, also include:

- The item number (eg. CU-00, SDP-00)
- Whether your comment is in favor or in opposition to the item

INSTRUCTIONS FOR PROVIDING PUBLIC COMMENT DURING THE MEETING:

- Individuals wishing to provide public comment at this meeting may provide public comment via the Zoom application or by telephone. Those who use the Zoom application are encouraged to turn on their video as well as audio so that the Commission can see them.
- Individuals wishing to provide public comment at this meeting must **sign up prior to the meeting**. It is advisable to sign up for public comment as early as possible but **no later than 5:00 PM Tuesday, October 13**. To sign up for public comment, email Danielle Sedillo-Molina at dmolina@losranchosnm.gov. Staff have the right to remove individuals from the meeting for poor etiquette, excessive noise, or any other behavior deemed a nuisance.
- **You must include in the email:**
 - Your first and last name
 - Your full address
 - Phone number you will call from (if applicable)If you are commenting on a public hearing item, also include:
 - The item number (eg. CU-00, SDP-00)
 - Whether your comment is in favor or in opposition to the item
