WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the 20th Annual ABBOTT GALAHER SeaMan Canoe Race, I the undersigned, intending to be legally bound hereby for myself, my heirs, executors and administrators, so waive and release any and all rights and claims for damages I may have against Keauhou Canoe Club, Hawaii Island Paddlesports Association,, its directors, members and sponsors:

1. Agree that prior to participating, I will inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will advise my team, coach or sponsor of such conditions and will refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own, but also the actions, inactions, or negligence of others, the rules of play, or the condition of the premises, or of any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
4. Release, waive, discharge and covenant not to sue Keauhou Canoe Club, HAWAII ISLAND PADDLESPTS ASSOCIATION, its respective organizers, administrators, directors, agents, coaches and other volunteers or employees, if any, of the organization; other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, including Kamehameha Schools, Bishop Holdings, the County and State of Hawaii, (hereinafter referred to as "releasees") from demands, losses or damages on account of injury, including death or damage to property, caused by or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

THE UNDERSIGNED HAS READ THE ABOVE WAIVER AND RELEASE, AND UNDERSTANDS THAT S/HE HAS GIVEN UP SUBSTANTIAL RIGHTS IN SIGNING IT, AND SIGNS IT VOLUNTARILY.
