It operates a community center, nursery school, primary school, and outpatient health clinic and provides a community health team, adult education classes, and school and community health programs. Program accomplishments include treating 4,477 patients at the clinic, monitoring the growth and health of 3,437 children, providing health education to young students, teaching over 100 health education classes to students in 3 grades, treating 5,234 community members in their homes, de-worming 781 children, educating 1,089 people about HIV/AIDS in their homes, distributing over 1,400 condoms, and providing 50 adults with basic and post-literacy education.
