Juror: Virginia Bradley

Virginia Bradley is a Professor of Art at the University of Delaware, where she teaches painting and drawing. She has been the recipient of several fellowships, including a McKnight Foundation Fellowship in Painting, Arts Midwest NEA Fellowship for Painting and two Minnesota State Arts Board Fellowships in Painting and Drawing. She has also completed several Percent for Art Commissions for the Minnesota State Arts Board. Bradley's work has been exhibited widely, venues include; Blue Star Center for the Arts, Hoyt Institute of Art, Freedman Gallery (Albright College) Abington Art Center, The Minneapolis Institute of Arts, The Soap Factory and The Florence Biennale (Italy).

Categories for original work: Painting, drawing, mixed media, sculpture, photography, ceramics, printmaking, and collage.

Giclees reproductions of original works are not eligible.

A Juried Exhibition open to Members of the West Hartford Art League

ELIGIBILITY:

All members are eligible to enter. Work must have been created during the last two calendar years and not previously exhibited in a juried WHAL show. Work must be suitably framed and wired for hanging. Wrapped canvases must be painted on sides with no staples showing. Framed dimensions may not exceed 50 inches on the longest side. Work on paper must be under glass or Plexiglass. Sculptures may not weigh more than 50 lbs.

For this exhibit, we will only accept work that is hand delivered. (no digital entries)

1. Pre-register: Please fill out the pre-registration form and send it to 37 Buena Vista Road, West Hartford, CT, 06107 by **Monday, September 25, 2017**. This is not a postmark date. Please include payment with form.

2. Fee for each entry: \$10. Up to four artworks may be submitted for \$40. Limit: two acceptances. Make checks payable to West Hartford Art League. Fees are non-refundable.

3. Drop off your work: **Receiving: Saturday, September 30, 10-12 noon.** Clubhouse Gallery.

Please note: in an effort to keep receiving lines short and quick, **PLEASE pre-register** your work.

4. Check our website: **Accepted work will be listed on our website** at www.westhartfordart.org Monday, October 2, by 6 p.m

5. Pick-up of unaccepted work: **Wednesday, October 4, 10 -12 noon Clubhouse Gallery. Identification is required.**

6. Opening reception and awards: **Sunday, October 8, 2-4 p.m.** Awards: 3 p.m. Clubhouse Gallery

7. CLOSE OF SHOW: No work may not be removed before 4:00 p.m. the last day of the show. Work not picked up **October 23** is left at the owner's risk and is subject to a \$5 per day storage fee, and is no longer the responsibility of the West Hartford Art League.

SALES: All artwork must be for sale. A 30% commission is taken on all sales.
