I understand and acknowledge that rowing is an activity that may cause injury. I participate in all Hawthorn Rowing Club (HRC) activities, regattas and events at my own risk. I hereby release exempt and indemnify Hawthorn Rowing Club, its committee of management, sponsors and agents in respect of all liability whatsoever and however caused, whether by negligence or otherwise, which may arise in connection with my participation in HRC activities or external regattas and agree that any statutory guarantees implied by the Australian Consumer Law and Fair Trading Act 2012 are excluded.

WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012
Under the Australian Consumer Law (Victoria) several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you:

- are rendered with due care and skill; and
- are reasonably fit for any purpose which you, either expressly or by implication, make known to the supplier; and
- might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the Australian Consumer Law and Fair Trading Act 2012, the supplier is entitled to ask you to agree that these statutory guarantees do not apply to you.
