Location: Olney Swim Centers, 16605 Georgia Avenue, Olney, MD 20832 (240) 777-4995

- 8 lane, 25 yard pool with separate area for warm up/cool down, continuous flow-through gutters, and non-turbulent lane dividers. Diving is not permitted in the warm up/cool down area.
- Water depth is 14' at the starting end and 4' 5" at the turn (bulk head) end of the pool.
- The competition course has not been certified in accordance with USA Swimming Rules and Regulations Article 104.2.2(C), because it is a bulkhead pool, which is measured in length prior to the start of the meet.
- Automatic timing (touch pads primary) will be used for this meet.

Meet Schedule: Saturday 500 Free; Sunday 1000 Free
Warm-ups: 1:15 – 1:50 PM Event Start: 2:00 PM

The Meet Director reserves the right to adjust meet warm-ups and start times based on entries received and the RMSC Autumn Mini Meet being run earlier in the day.

Warm-Up Procedures: The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed. The Meet Director may determine the structure of the warm-up; times/lane assignments.

Eligibility: This meet is an RMSC inter-squad meet. Swimmers will compete at the age attained on the first day of the meet. No on-deck USAS registration permitted.

PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.

Rules: Current USA Swimming rules will govern this meet.

- Seed times are short course yards.
- An 8-lane course will be used.
- All events are timed finals, swum fastest to slowest, alternating girls and boys heats.
- The Meet Director reserves the right to combine heats or events based on the number of entries received and the meet timeline.
- The Meet Director reserves the right to limit the number of entries in the 500/1000 due to time constraints, if necessary, based on fastest entry times.
- The event will be positive check-in and deck seeded.
- Swimmers will be responsible for providing their own timers and counter.
- Dive-over starts will be used.

Qualifying Times:

- There will be no qualifying times however, each site of RMSC will be given a certain number of slots for the 500 and 1000 Free.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for the 12 &U sessions in Rule 205.3.1F.

In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDS's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Warning: Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2016/2017.

- Entry Fees: \$7.00 per event.
- **Entry Deadline: Tuesday, November 1, 2016 at 11:59 PM.**
- No late entries will be accepted.
- Meet Directors are requested to acknowledge receipt by return e-mail within 24 hours. Clubs submitting entries that do NOT receive an acknowledgement should contact the Meet Director by other than e-mail to confirm receipt.

Entry Procedures:

Swim Center Rules and Conduct

At the request of [Montgomery County Recreation](#), swimmers are not to leave the pool deck without appropriate attire. Coaches will be responsible for the conduct of their athletes while in the facility and surrounding grounds. Failure to follow these rules or any inappropriate behavior will result in the athlete being barred from further competition in the meet. Parents will be responsible for the conduct of any minor children that accompany them.

- No glass containers are permitted within the facility.
- Swimmers must be in direct contact with their supervising coach before they will be allowed to enter the pool for warm-up.
- No camera cell phones are permitted in the locker rooms.

In granting this sanction it is understood and agreed that USA Swimming, Potomac Valley Swimming, Olney Swim Center, Rockville Montgomery Swim Club and Montgomery County Recreation shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
