Principal Author actions

I have appreciated receiving feedback from some *Principal Authors* about actions taken to contact *Supporting Authors*; to improve the Chapter content beyond the bullet points provided; and, to develop a plan for a Chapter with author responsibilities identified. This is great work and is appreciated. Later, I will be asking each *Principal Author* for an outline of their final Chapter plan so that I can upgrade the overall Book Plan.

Two Chapters merged

At the request of two *Principal Authors*, Chapters 20 and 21 of the original Book Plan have been merged. The “Managing for Biodiversity” and “Managing for Ecological Processes and Ecosystem Services” Chapters will be integrated to form one Chapter. The Book Plan will be upgraded to recognise this change.

Additional refinements

We expect that the Chapter content identified by the Book Plan will be further “tweaked” by *Principle Authors*; by the Book Steering Committee; by inputs from WCPA Specialist Groups and Task Force members and by other experts. This refinement is a natural and planned part of the development of the book, it will help creativity; it lead to the best possible content and it will help refine how and where information is presented. We are not expecting changes to the key Chapters but there may be fine tuning of what information is presented and where it is presented. The Book Plan (for example) identified for some topics, these same topic headings in different chapters. This was to emphasise the need for cross-referencing. The intent was always for the Book to include the core content for the topic in one Chapter only, with other Chapters reinforcing the topic where appropriate and cross-referencing to the core text. We will be clarifying these matters with *Principal Authors*.

Word limit

We need to be very careful with the number of words used. We have advised in the *Guidance for Authors* that the Chapters should be about 20,000 words. Based on a request from the Book Steering Committee we are refining this advice. Chapters should be no more than 20,000 words and preferably somewhere between 10,000 to 20,000 words in length. Having said this, we would prefer Chapters to be a premium educational product and that key information should be included. Highly relevant and well written Case Studies (for example) at 800 words each are a rich source of learning material and they are considered essential parts of a Chapter. It is understood (and it is considered acceptable) that a number of Case Studies will be used even though they will quickly increase the number of words for a Chapter.

Innovative chapter titles

We are looking for innovative titles for chapters given the Book Plan titles are considered indicative only. The titles should be brief, clear, cover the subject matter, and should be different to those presented in the 2006 book.

Content

Principal Authors are encouraged by the Book Steering Committee to aim (where appropriate) for their Chapters to include material from Low Human Development Index countries and from settings where community approaches to conservation predominate.

WCPA Steering Committee Meeting, Montenegro, April 2013

Many *Principal* and *Supporting Authors* are members of the WCPA Steering Committee and as part of the April 2013 Montenegro WCPA Steering Committee meeting a Book Project meeting will be held on the 22 April 2013. We plan to discuss some of the refinements discussed above at the meeting. Matters discussed and agreed at Montenegro will be subject of Newsletter No 3.

Montenegro video interviews

In Montenegro, Jamie Kemsey and I plan to conduct a number of brief (2 minute) video interviews with *Principal Authors* and potential *Supporting Authors* present about their Chapter in the E-Book. In addition, we plan to interview key players of the IUCN Capacity Building project of which the E Book is an integral part. Our aim is to bring the Book Project to life on our Web Site....to set its context as one part of the larger IUCN capacity building initiative and to provide a chance for authors to be passionate about their chapter and how it will help future protected area managers.

Recommended Supporting Authors

In planning this book project, the Editors took the initiative to recommend a number of protected area experts as potential supporting authors for the *Principal Authors*. The idea was for these experts to be potentially invited by the *Principal Author* to contribute to parts of the Chapter text. In addition, the *Principal Author* could choose to involve other experts. In early April, this contacting process by *Principal Authors* was either finished, still underway or yet to be started. Once *Principal Authors* have finalised their team of *Supporting Authors* for their Chapter, we will recognise all of our book authors in this Newsletter and on our Website. We already know that this will be a formidable list of experts!

Involvement of WCPA Task Forces, Specialist Groups and Best Practice Series authors

The editors aim for the book to be fully integrated with the best WCPA information available and especially the work of Specialist Groups and Task Forces. This includes the WCPA Best Practice Guidance material and we anticipate that this information will underpin many chapters, will be recommended reading and if possible, will be e-linked by the text of the book. We also anticipate that many WCPA Best Practice Authors and Task Force and Specialist Group members will either participate as *Supporting Authors* or could assist *Supporting Authors*. We certainly encourage contact between any such WCPA members and *Principal Authors* to foster interest in and potential contribution to the book. To assist these potential contacts, I will be posting on the Website information that links WCPA's greater organisational team and how their area of expertise overlaps with the book content.

Next Newsletter

The next Newsletter is planned for late May 2013. It will report on the outcomes from the WCPA Montenegro meeting and further progress achieved with the book project.
