## **Enforcement and Compliance**

#### **Summary**

Since the last Council meeting, there were 147 documented patrols, allowing critical face-to-face interaction between our field staff and the industry; 121 documented instances of outreach (not an exhaustive list; includes phone calls with industry, dock visits, trade shows, presentations, etc.); and 13 meetings. This list does not include the extensive outreach that the VMS team provides on a daily basis, nor can it fully capture the interaction our agents, officers, and support staff regularly have with industry.




Figure 1: 524 incidents reported from April 1, 2018 through June 30, 2018. The chart is broken down by patrols, outreach, and meetings.




Figure 2: Incidents opened from April 1, 2018 through June 30, 2018. 524 incidents were opened.




Figure 3. Status of incidents from April 1, 2018 – June 30, 2018 (408 completed, 116 ongoing).




Figure 4. Incident Dispositions from April 1, 2018 – June 30, 2018 (408 completed, 116 ongoing)

## **Enforcement Highlights**

#### Right Whale Outreach

An OLE officer responded to a situation involving right whales in close proximity to a popular Massachusetts beach. The officer conducted outreach on multiple violations of the 500 yard approach rule. The officer partnered with the Protected Resources Division to hold an outreach event on site. Hundreds of questions were answered and a lecture was provided to a fifth grade class of about 50 students. The event was featured in a local paper and WCVB evening news.

#### Whale Teeth Smuggling

John "Jake" Bell, pleaded guilty to one count of wildlife trafficking in violation to the Lacey Act. Bell, who was living in the Ukraine from about 2008 until his arrest at JFK Airport in December 2017, trafficked teeth from endangered sperm whales and sold them to customers in the United States.

## **Focused Operations**

#### **Observer Refusal Operation**

In April 2018, the National Marine Fisheries Service, Observer Program requested OLE's assistance in targeting coastal Virginia for a focused effort on observer compliance. The request indicated that there was a high rate of observer refusals projected to occur in May 2018. OLE staff worked cooperatively with the observer program coordinators in the Mid-Atlantic to develop a plan to conduct outreach related to observer coverage requirements, safety requirements, and address any potential violations detected during operational patrols.

The operation began on April 18, 2018 and ran until May 31, 2018. The primary locations for patrols were Chincoteague, Virginia Beach, Newport News and Hampton, Virginia. The majority of the vessels contacted were participating in the gillnet fishery, targeting spiny dogfish. The operation included an outreach meeting with a group of commercial captains in Lynnhaven, Virginia. During the course of the operation 5 violations were detected; 2 of the violations are ongoing and 3 were addressed through compliance assistance.

#### Mid-Atlantic Atlantic Large Whale Take Reduction (ALWTRP) Operation

With the increase in deceased whales showing up on the Mid-Atlantic shoreline, ensuring compliance with ALWTRP regulations is important and necessary in reducing the amount of mortalities caused by gear entanglement. This year, New Jersey Fish & Wildlife purchased an off-shore patrol vessel capable of hauling pots/traps, which will aid in ensuring ALWTRP regulations are enforced appropriately in the future.

The operation began on April 9, 2018 and ran until May 31, 2018. The primary locations for patrols were LMA 4 and 5, while dockside inspections took place in Point Pleasant Beach, NJ. The majority of the vessels contacted were participating in the pot/trap and gillnet fisheries. During the course of the operation 84 violations were detected.

#### **Great South Channel ALWTRP Operation**

The annual Great South Channel restricted area ran from April 1 – May 2, 2018. The area is expansive and located approximately 8.5 nm East of Chatham at the most Western point. The Protected Resource Division at GARFO expressed concern to OLE that gear was likely in the area based on historical data. There was also no focused enforcement of this area in the past. Additionally, a quarter of the critically endangered north atlantic right whale moved into the waters off Massachusetts around the same time. In order to enforce the offshore closure, OLE coordinated with the USCG, who agreed to collaborate by offering surface and air support.

Operations were conducted during the 3-month period that the Great South Channel Restricted Area was closed to trap/pot gear in accordance with the ALWTRP. This area is closed to fixed gear for a period of time to mitigate increasing numbers of large whale entanglements, particularly the critically endangered, North Atlantic right whale. The patrols observed 100% compliance during the operation.

#### Northern Gulf of Maine (NGOM) Scallop Operation

The operation was in preparation for the competitive and derby style NGOM Scallop season. The NGOM scallop season ran from April 1 – May 2, 2018 and the operation lasted for the duration of the season. The primary landing port was Gloucester, MA, with some landings in Portsmouth, NH, Newburyport, MA, and Scituate, MA. The majority of the participating vessels were transient, relocating from Maine to Gloucester for the fishery. The fishing grounds were almost exclusively in an area of Stellwagen Bank National Marine Sanctuary known as 'Middle Bank', about 25 nm Southeast of Gloucester. The regulations were modified this year, which prevented the limited access vessels from participating in the fishery. This appeared to reduce the number of complaints received and some of the competitiveness of the fishery.

Thirty four of the 37 vessels participating in the fishery were boarded, resulting in a 92% contact rate. A total of 18 violations were documented on 16 vessels throughout the 52 boardings. Most violations were minor and handled with compliance assistance. Only one \$500 SS was issued for failure to renew permit. This is the first year since the inception of the fishery where a Notice of Violation and Assessment (NOVA) was not issued.

Note: There are 434 groundfish sector vessels and 119 common pool vessels registered to the NE VMS Program. There are 15 sector and 3 common pool vessels on a NMFS-authorized power down Letter of Exemption.

#### Significant VMS Issues:

**Next Software Upgrade for Northeast-equipped VMS Vessels**. New software (referred to as 'Format 15') was tested/approved by OLE and released by the vendors in April 2018 to comply with Scallop Framework 29, and the Squid, Mackerel Butterfish and Surfclam/Ocean Quahog FMPs.

**Omnibus EFH Amendment**. New regulatory area updates were made to OLE's satellite monitoring system, vTrack, and monitoring of these areas was effectively implemented as of April 9, 2018.

#### VMS Industry Contact Log Report:

The NE VMS Team addressed 634 industry issues this quarter and closed 441 issues. The most-frequently reported issues were Declaration/Forms Assistance, Eforms Compliance, and Declaration Failure. A total of 36 issues were referred, primarily to VMS vendors, Observer Program, and GARFO APSD.




Figure 5: Status of contacts from April 1, 2018 – June 30, 2018 (441 closed, 193 remain open).
