*Jeep Wrangler when Mrs. Levine's vehicle crossed into his lane of travel. The front of the Jeep collided with the rear driver's side of the Chevrolet in the eastbound lane. The collision spun the Chevrolet and ejected Mrs. Levine from her vehicle. Despite efforts from Medford Township Police, Fire, EMS Mrs. Levine succumbed to her injuries at the crash scene. Mr. Nahill was not injured. The crash is still under investigation by the Medford Township Police Traffic Safety Unit.*
