BOATING RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being given the opportunity to participate in any DOWNTOWN BOATHOUSE INC. ("Boathouse") activities ("Activity") until the end of this calendar year, I, for myself, my personal representatives, heirs, and next of kin:

- 1. ACKNOWLEDGE, agree, and represent that I understand the nature of Boating Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity;
- 2. FULLY UNDERSTAND that: (a) BOATING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b) these risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity;
- 3. AGREE AND WARRANT that I will examine and inspect each Activity in which I take part as a member of the Boathouse and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity until the condition has been corrected to my satisfaction; I also acknowledge that I understand the U.S. Coast Guard's security rules with respect to maintaining the required distance from the Passenger Ship Terminal (Piers 88, 90 and 92), and will obey accordingly;
- 4. HEREBY RELEASE, discharge, and covenant not to sue National Paddling Committee, Inc. dba USA Canoe/Kayak, the HUDSON RIVER PARK TRUST, the CITY OF NEW YORK, the STATE OF NEW YORK, or the DOWNTOWN BOATHOUSE INC., their administrators, directors, agents, officers, volunteers, and employees, other participants, regatta organizers, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the Releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of these Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss, liability damage, or cost which any may incur as the result of such claim.
- 5. ACCEPT NON-VOTING ANNUAL MEMBERSHIP in Downtown Boathouse Inc. with all the rights and responsibilities appurtenant thereto.
