- **adequate space for the photo area**
10x10 ft space (fusion booth/party portraits)
8x8 ft space (luxé + stand up booth)
- **1-2 hours of setup** time before start of the event
- **access** from loading area to photo area must be a smooth, paved walkway or accessible by a commercial van. In case of the event not being on the ground level, there must be elevator access. Area must be level and dry. Area must also be in a shaded covered area (unless prior arrangements have been made). Area must be out of direct sunlight and away from any gusts of wind. Any damage to photo equipment because lack of the following will be at the client's expense.
- **a standard 110V, 10amps, 3 prong electrical outlet** (standard household outlet) and a **4ft or 6ft table** for any props or photo equipment.
- **responsibility** for any negligent or intentional damage to the photo equipment, props, or any belongings of Photo Ops LLC
- **\$150 deposit** at the signing of this contract to secure the date (refundable if cancellation made within 60 days of the event) remaining balance is due 7 days prior to the event. If balance is not paid on time, the deposit shall be forfeited and reservation cancelled.

PHOTO OPS LLC agrees to provide the following:

- **services** specified on the client info form (previous page) operational for a minimum of 90% of the event duration and times specified on the form. occasionally, operations may need to be interrupted for printer service, reloading of paper, power failure etc.

PHOTO OPS LLC will be exempt for any claims, actions, suits, cost damages or liabilities, including but not limited to liability for personal injury or any person at the event, property damage, and/or wrongful death, if caused by negligence on the part of PHOTO OPS LLC or any of its agents, owners, or employees.
