PROJECT DESCRIPTION

127th Street & El Segundo Apartments represents a new, 2-phased, 160-unit supportive housing and affordable rental development in the Harbor Gateway area of Los Angeles. The first phase, 127th Street Apartments, will provide 84 special needs units for formerly homeless individuals, plus a superintendent's unit. Phase 2, El Segundo Apartments, will provide 75 units, including 37 for special needs occupants and 37 for low-income families earning up to 50% AMI, plus one superintendent's unit. The supportive units in both phases will target frequent utilizers of Los Angeles County's Department of Health Services. Construction is scheduled to commence in December 2015 and October 2016 for Phase 1 and 2 respectively.
