The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Jery Bailey presiding and the following members of the City Council present: Lawrence Hoerman, James Barber, Leon Birney, Tom Stoppel and Dylan Shotton. Also present were City Attorney Lynn Koehn, Sheriff Troy Briggs, City Superintendent Daylen Elsey, Zoning Administrator Jarrod Weeks, John Hall, Assistant Fire Chief and City Clerk Jeannie Trigg. Visitors was Erica Shotton.

Mayor Bailey opened with a prayer.

Mayor Bailey opened the public budget hearing at 7:00 p.m. The Mayor opened up comments for the 2016 budget hearing. There were no members of the public present to question the budget. The proposed mill levy for 2016 is 52.000. After comments during the public hearing a motion was made by Councilmember Barber, seconded by Councilmember Hoerman, to adopt the budget at the mill levy at 52.000 for 2016. The motion carried 5-0.

The minutes of the last regular meeting and special meetings were approved as distributed with a motion by Councilmember Birney, seconded by Councilmember Stoppel. The motion carried 5-0.

Mayor Bailey commended the Council and thanked them for their support and work on the new playground at the City Park.

Sheriff Briggs gave the monthly law enforcement report for the City. He discussed drug issues in the City.

Assistant Fire Chief Hall reported on fire runs. He reported on some repairs and recalls on the new firetruck. He discussed bunker gear replacement.

Superintendent Elsey gave the monthly water report. He discussed repairs on the Vactron.

A motion was made by Councilmember Barber, seconded by Councilmember Birney to purchase a Vactron VX30-500G at the cost of \$32,500.00 form Vermeer Great Plains.

The motion carried 5-0. He reported street sealing scheduled for September 12th and 13th.

Zoning Administrator Jarrod Weeks discussed transition of his position to a new zoning administrator. He discussed zoning issues that are in the works at this time.

The Council discussed hiring a zoning administrator to replace Jarrod Weeks. A motion was made by Councilmember Barber, seconded by Councilmember Birney to hire Jim Kaup as the zoning administrator and sign the contract. The motion carried 5-0.

A motion was made by Councilmember Hoerman, seconded by Councilmember Birney to approve and allow payment of the bills as distributed with exception of AT& T. The motion carried 5-0, with Councilmember Barber abstaining from Barber Sales and Repairs and Leon Birney from Birney Construction.

Councilmember Barber made a motion to adjourn, seconded by Councilmember Shotton. The motion carried 5-0.
