- Orders can be picked up in Walden, NY or GlenRock, PA. Person picking up must provide copy of drivers license.
- Delivery is available for an additional charge. Free delivery to Crackerjacks, PA Artists and MPAG club shoots.
- We strongly encourage all new customers to buy a copy of NFPA 1123: Code for Fireworks Display or NFPA 1126: Use of Pyrotechnics before a Proximate Audience. These codes are required to be followed in many states. They are avail- able from NFPA at [www.nfpa.org](http://www.nfpa.org) or by calling 1-800-344-3555.
- 18 U.S.C. 845 EXEMPTS Federal, State and Local government entities from most provisions of Federal regulations regarding explosives. Federal, State and Local government entities, or their political subdivisions, will NOT be re- quired to obtain a license or permit to acquire display fireworks. Political subdivisions would include educational in- stitutions operated by Federal, State or Local governments (e.q. public schools). Persons possessing display fireworks on behalf of Federal, State and Local government entities or public educational institutions will not be subject to re- strictions so long as their possession is in the scope of their employment.
