

**Informed Consent and Disclaimer for the services of

I hereby attest to the following:

1. That I am here on this, and any subsequent visit, solely on my own behalf and not as an agent for any federal, provincial or municipal agency on a mission of entrapment or investigation.
2. I fully understand that Manjiri Nadkarni, M.D. (Ayurveda), R.H.N., C.B.A.C. is not a medical doctor, and I am not here for medical diagnostic or treatment procedures. If I have any health problems, health condition, or disease, I am now being advised not to postpone or delay getting competent medical advice from a licensed doctor of medicine. I understand and agree that any services rendered by Manjiri Nadkarni, M.D. (Ayurveda), R.H.N., C.B.A.C. are not designed to diagnose, cure or prevent any disease, pain, deformity, injury or mental or physical condition of any kind. I am here to learn how to do this for myself.

The services performed by Manjiri Nadkarni, M.D. (Ayurveda), R.H.N., C.B.A.C. are at all times restricted to consultation on the subject of nutrition intended for building wellness and does not involve the diagnosing, prognosticating, treatment, or prescribing of remedies for the treatment of disease, or for any act for which a medical licence is required.

We believe it is not important to name diseases. It is much more important to start individuals back on the road to proper nutrition and other healthful habits.

I DO agree to allow my information to be shared with my Medical doctor, Naturopathic Doctor, Homeopathic Practitioner, or other healthcare professional if there is a medical emergency or when working with multiple practitioners to ensure proper advice is given, and only when I am made aware prior to.
7. **LICENSURE:** A holistic nutritionist is not licensed or certified by any province. However, a holistic nutritionist is board certified in Practical Holistic Nutrition by the Canadian Association of Holistic Nutrition Professionals, which provides a certificate of board certification to graduates of a recognized holistic nutrition school. **A Holistic nutritionist is not trained to provide medical diagnoses, and no comment or recommendation should be construed as being a medical diagnosis.** Since every human being is unique, we cannot guarantee any specific results from our programs.
8. **Exam:** A license to practice holistic nutrition is not required in Canada. However, a holistic nutritionist should be board certified by the Canadian Association of Holistic Nutrition Professionals and will have completed a board certification exam.
