I assume these Risks while attending any class or any other function of the Club, or while in the training facility.

As a condition of my acceptance of my application for training and/or membership by this Club, I and my Invitees hereby agree to indemnify and hold harmless the Club, it's employers, officers, members, directors, lessors, landlords and agents from any and all claims, losses or expenses, including legal fees (hereinafter "Claims"), while participating in any Club class or event, or while on the grounds or the surrounding area thereto, as a result of any action by any dog, including my own.

By participating in classes or events at GNDOC, I understand that both I and/or my dog(s) will be working with, exposed to or otherwise be in the presence of other dogs. I understand that GNDOC and the Club do not warrant or otherwise insure my (the) safety of me or my dog during classes and/or events hosted by GNDOC.

In the event that either my dog or I are injured by another dog prior to, during or following an event hosted by GNDOC, I agree to hold harmless GNDOC, the Club, and any Lessor or landlord for any Risks or Claims suffered or sustained by myself or my Invitees and/or my dog(s).
