

Buying Club Member Agreement

We, Re:Vision, are excited to bring you high-quality, natural & organic products at competitive prices and dropped off to a location of your choosing through a buying club. If you have general questions about how this all works, please visit www.revision.coop/buyingclub and click on the FAQ list.

This agreement outlines our shared commitments to this relationship between you, the consumer, and us, the provider.

Section 1. Introducing Our Buying Club

A. Becoming a Part of Our Family

A buying club is the idea of a group of people purchasing items in bulk then sharing them in order to get specialty products at competitive prices. Re:Vision locates the specialty products, purchases them in bulk, and delivers the ones you want to a drop-off location near you.

We started this buying club in order to provide natural and organic foods to members of the Re:Vision community. We charge a very small amount over wholesale costs (called a markup) to keep the prices low while also making a small profit that will allow us to open our own storefront.

B. Our Products

All the products sourced for the buying club are from trusted and local or regional producers or distributors. As we grow, so will our relationships with different producers.

C. The Products We Expect for 2014

We will initially have a smaller selection of products as we get our operational infrastructure in place. Starting in early 2015, we plan to expand to Colorado seasonal fruits and veggies! Check back often for new products or sign up for our weekly update email.

Section 2. Picking Up Your Orders

You are responsible for picking up your orders each week that you order from the pickup location you selected at the time of checkout.

You are responsible for observing our drop site rules, which are as follows:

1. Bring your own bag and leave the coolers closed tightly at the site
2. Pick up your share within the timeframe stated.
3. Be respectful of our drop site hosts' property.
4. Follow additional rules posted at your drop site regarding parking/use of certain entrances/boxes.

If you cannot pick-up your orders, you must arrange for someone else to pick it up for you, or contact us at csa@revision.coop 48 hours before the slated pickup time in order to arrange alternative plans. You are responsible for explaining the pick-up location and procedures to your substitute. Orders not retrieved within the pick-up time will be collected and distributed at the discretion of Re:Vision.

We take the safety of your food seriously. Although we are of a small enough scale to not fall under USDA regulations, we make food safety our top priority at the farm. If you'd like to see detailed food safety procedures, please ask! It is always important to remember that although we rinse many of the products

at the farm, *you must wash everything before you eat it* – just like you would if you bought them from the grocery store. To follow organic growing practices, Re:Vision does not spray its produce with any chemicals including bleach. We will be the first to communicate any suspected contamination with you should it occur.

Section 4. Member Fees

WAIVER – all buying club membership fees are waived through early 2015.

Buying clubs all over the nation are springing up, and usually the organizing entity asks for a one-time, non-refundable membership fee to help with the overhead and product logistics. Re:Vision is asking you to show your support and commitment to rethinking our food system by purchasing a membership by way of a one-time \$35 fee.

We will communicate with you by email. When you sign up, you will be added to our distribution list. Please read your email from us. We depend on being able to communicate important information such as necessary changes to your distribution schedule or to our farm events. Every week, we will email an update or newsletter giving you information about the products available that week, recipe ideas, or other food and organization-related news.

By signing up and paying for your orders either in person or on our website, you agree to abide by the letter and spirit of this agreement. If there is any material change to this agreement, you understand that Re:Vision will communicate that to you in writing.
