MEMBERS ARE REQUIRED TO BE FAMILIAR WITH RULES

RULES OF THE POOL - 2017

1. Members are responsible for:
 - a. signing in the names of all members and guests; sign-in notebook at the pool desk.
 - b. paying any fees when they arrive and prior to swimming or using the facilities.
 - c. Knowing when your membership has expired.
2. No running. No skateboards or other disruptive behavior that may cause a hazardous condition.
3. No pets and no glass are allowed in the pool or clubhouse.
4. Anyone under the age of 18 years must be accompanied by a parent or designated member adult. (Anyone Members who appears even slightly under the age of 18 may be asked for proof of age.)
5. Food and drinks are not allowed in the pool. Please picnic in designated areas only and clean up after use.
6. Pool toys that disrupt other swimmers and sunbathers, and excessively loud screaming are not allowed.
7. Closing time means closing time. All swimmers must be out of the pool before the posted pool closing time. Only adults may be present in the pool and deck area during Adult Swim Hours.
8. PARENTS MUST SUPERVISE CHILDREN AT ALL TIMES, including while using the bathroom and shower areas. Every effort should be made to promote safety and water conservation.
9. If there is any question about a child's toilet training, the child must wear Little Swimmers or similar quality protection. All children under 2 ½ yrs of age shall wear such protection.
10. Gum, popcorn, sunflower seeds or any other shelled nuts are not allowed anywhere inside the fenced pool area.
11. Smoking, including ecigarettes and vaporizers, is prohibited within the pool fenced area. All forms of smoking are allowed in designated areas only (located to the front of the clubhouse).
12. Swim Club members may only use Pinecrest and its facilities during hours when the Swim Club is open.

NO LIFE GUARD ON DUTY

DEFINITIONS OF MEMBERSHIP CATEGORIES

- Family: Parents (or grandparents) and up to four children (or grandchildren); children 3 yrs of age and older are included in maximum number of children
- Couple: Consists of two married or co-habiting adults, or a parent and one child
- Single: one person

4. By signing this Agreement the Swim Club Member agrees to abide by the Rules of the Pool (dated Summer 2017) that are attached to this agreement. These rules may be modified from time-to-time by Pinecrest.
