2. Test applications, (including Test Fees), Special Scheduling requests for applicants and their coaches, and compliance with the 27 day rule for retrying tests are the responsibility of the applicants, their parents and guardians.
3. Test Fees may be paid by VISA, MasterCard, Discover Card or a check made payable to "Power Play Rinks". A \$40 fee shall be charged for all checks returned by the Bank for any reason.
4. We will do our best to accommodate any written special scheduling requests, however, there is no guarantee as scheduling involves many variables.
5. Test Fees are non-refundable and all fees are forfeited if the applicant withdraws from a test for any reason. In the event that Exton Edge FSC cancels a test session, all fees will be refunded to the applicant.
6. **Applicants should be prepared to test up to one hour before their scheduled time.** If the test Session runs early and the applicant is not present or prepared to test, the applicant forfeits all fees for that test.
